
In pursuance of the provisions of Section 28 of the Guru Gobind Singh Indraprastha University Act,1998 (9 of 1998),the Board of Management of Guru Gobind Singh Indraprastha University (BM63.04) hereby makes the following guidelines for the consideration of any equivalence of degree:

**1.Short title, Application and Commencement**

- (i) These regulations shall be called Guru Gobind Singh Indraprastha University guidelines for consideration of any equivalence of degree.
- (ii)They shall apply to all the University Schools of Studies (USS) and Centres, Affiliated Colleges /Institutions, Constituent Colleges and University approved Research Centres.
- (iii) These guidelines will come into force immediately from the date of approval in the Board of Management i.e. 14<sup>th</sup> June 2016. The regulations will also be displayed on the University website.

**2. The regulations for consideration of any equivalence of degree:**

- (i)The University shall not issue any equivalence certificate for the degrees issued from (admission) Academic Session 2016-2017.
- (ii)The equivalence of degree procedure and policy for equivalence of Bachelor of Technology (Mechanical and Automation Engineering) and Bachelor of Technology (Mechanical Engineering) as approved by the Academic Council shall continue for the students admitted in the 1<sup>st</sup> year till the Academic Session 2015-2016.
- (ii)The University Shall issue equivalence certificates for the degrees issued before Academic Session 2016-2017 in consonance with the University decision regarding Nomenclature of degrees as per UGC regulation.
