SUBJECT: REGARDING CORRECTION IN THE DETAILS OF ONLINE APPLICATIONS FILLED UP BY THE CANDIDATES WHILE APPLYING FOR MBA (CET CODE 101) FOR THE ACADEMIC SESSION 2019-20.

In continuation of earlier University notification under above reference and in continuation of Important Instruction given in Part-A of Admission Brochure 2019-20 at point 9 of para 1.9 (page 11) whereby it is mentioned that "After the application for any CET is submitted, if there is any mistake in date of birth, spelling mistake in name of applicants or the parents name or in the choice of category/region claimed for the purpose of availing reservation, the applicant must submit an application in physical form (together with applicable processing fees of Rs. 500/-) to: Reception, Examination Division, Guru Gobind Singh Indraprastha University, Delhi".

The University vide notifications dated 13.06.2019, 17.06.2019 and 27.06.2019 under above reference has already given opportunity for removal of discrepancies/mistakes in the application form filled up by the candidates while applying for MBA (CET CODE 101) for the academic session 2019-20. However, all such candidates with specific reference to the **MBA** (CET CODE 101) only for the academic session 2019-20 are given final opportunity to remove their discrepancies observed/found in their application forms filled online for MBA (CET CODE 101).


Based on the record available with the University, the following list of the Registered applicants for MBA (CET CODE 101) are attached herewith for information and necessary action (wherever required) of the concerned candidates:

1. List - 1: Application forms received for MBA (CET CODE 101) for Academic Session 2019-20, list is attached.

The admission in MBA (CET Code 101) for Academic Session 2019-20 is to be on the score/ merit of CAT 2018. All applicant/ candidate are requested to go through the list and see/ verify that the CAT registration (CAT_REGNO) as per details against their respective details is correctly specified as CAT 2018 registration number of candidates / applicants. Those applicants whose CAT registration number is incorrectly specified shall not be eligible for admission unless they furnish the correct details to University. Those who have not appeared in CAT 2018 are not eligible for admission.

This is the last opportunity for corrections in the application for admissions to MBA (CET Code 101) for the Academic Session 2019-20.

It is again reiterated that the candidates are requested to go through the above stated lists carefully and note the details mentioned therein, if any correction/discrepancy is observed as stated



above or otherwise like CAT-2018 Roll Numbers etc., are advised to see their names in the respective list, and if any; discrepancy is observed, then they have to submit the request application for corrections in physical form along with copy of fee challan of Rs. 500/- submitted in Indian Bank Branch at GGSIP University, Dwarka, Sector 16C, New Delhi. The candidate must submit the application along with relevant document in support of removal of discrepancies and challan of Rs. 500/- at the Enquiry Window of the Admissions Branch, GGSIP University, Sector 16C, Dwarka, New Delhi – 110078 on 08.07.2019 (10.30 a.m to 04:00 p.m.) The challan based payment is to be done at Indian Bank Branch at GGSIPU Campus, the facility shall be available till banking hours only. For consideration of change required to be in EWS category, the application request is required to be submitted on the above notified dates. However, no payment is required in case of change of existing category to EWS category. No request for removal of discrepancies through email shall be entertained.

All concerned may please note that this is last opportunity given to the candidates for removal of their discrepancies in their details so filled in their application form.
