50% of seats are reserved for any candidate with M.A.(English) or equivalent degree from any UGC recognized University. These candidates shall have to appear in the CET conducted by the University.

Seats of any of the above groups are interconvertable, if remaining vacant.

4. **Documents Required for Verification and Allotment of Seats:**

- a) Bank Draft(s) of Rs. 71,000/- in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no, name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s).
- b) Four passport sized photographs (same as that in admit card)
- c) CET Admit Card 2019 in Original.
- d) Proof of date of birth (Secondary School Mark-sheet & Certificate) (**Original and Photocopy**)
- e) **Mark-sheets / Certificates of qualifying examination:**
The candidate will be required to bring the Original certificates / Mark-sheets of all the **year wise or semester wise** in original along with photocopy of Certificates / Mark-sheets of qualifying examination.
- f) **For Distance / Open Learning Cases:**
In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.
- g) **Physical Fitness Certificate:**
All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-B in Admission Brochure 2019-20 (As per Appendix 6).
- h) **Reserved Category Certificate:**
All reservation category candidates who are seeking admission in reserved category in SC / ST / DEF / PWD / KM must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. Appendix 1, Part B, Admissions Brochure 2019-20 alongwith the relevant entitled certificates, if admission is claimed in Defence Category.

Reservation to the EWS section shall be provided in Central Educational Institutions (as defined in clause (d) of Section (2) of the Central Educational Institutions (Reservation in Admission Act, 2006).
