MBBS – STRAY VACANCY ROUND 2021-22

SCHEDULE FOR OFFLINE COUNSELLING/ALLOTMENT OF SEATS IN STRAY VACANCY ROUND ON 22ND APRIL 2022 FOR ADMISSION IN MBBS PROGRAMME (CODE 103) FOR ACADEMIC SESSION 2021-22 WITH DETAILED INSTRUCTIONS FOR CANDIDATES.

NOTE:

Candidates are advised to refer the judgement of the Hon'ble Supreme Court of India in the case of Dar us Slam vs Educational Trust & Ors. In Writ Petition No.267/2017 dated 9.5.2017 and also to the Sub-Point 5, Appendix 'F' of the Medical Council of India Regulations on Graduate Medical Education, 1997 (Amended upto May, 2018) published in The Gazette of India vide notification no. MCI-34(41)/2018-Med./109835 dated 18th May, 2018 which relates to the Matrix that shall be applicable with regard to permissibility to students to exercise fresh choice during counselling.

Any change in reservation policy, if taken by the Government of India/NCT of Delhi or the University, the counselling will be conducted in accordance to that.

All counseling shall be held according to the directions of the statutory regulatory body, Govt. of India, Govt. of NCT of Delhi, Hon'ble Court(s) and/or the University.

THE UNIVERSITY SHALL CONDUCT THE STRAY VACANCY ROUND THROUGH OFFLINE MODE FOR ADMISSION IN MBBS ON THE BASIS OF MERIT FROM AMONG THE NEET UG 2021 QUALIFIED CANDIDATES WHO HAVE REGISTERED WITH THE GGSIP UNIVERSITY AND HAVE ALSO PAID THE FEE OF RS. 1200/- AND RS.1000/-.

THE TENTATIVE VACANCY SEAT STATUS FOR STRAY VACANCY ROUND IS AS BELOW:

DR. BSA MEDICAL COLLEGE & HOSPITAL – 03 (DGEN – 01, DST – 01, DOBC – 01)

THE CANDIDATES MUST READ THE SCHEDULE CAREFULLY. THIS SCHEDULE CONTAINS THE DATE AND TIME FOR REPORTING OF CANDIDATES IN PERSON AT THE COUNSELLING VENUE FOR VERIFICATION OF DOCUMENTS AS WELL AS VERIFICATION OF ELIGIBILITY AND THEREAFTER FOR ALLOTMENT OF THE SEATS.

THE CANDIDATE SHALL HAVE THE RIGHT TO EXERCISE THE CHOICE OF HIS/HER COLLEGE AT HIS/HER RANK SUBJECT TO AVAILABILITY OF THE SEAT IN HIS/HER CATEGORY.

THE UNIVERSITY SHALL DECLARE CLOSURE OF THE STRAY VACANCY ROUND COUNSELLING AS AND WHEN ALL THE VACANT SEATS ARE FILLED UP IN ORDER OF MERIT FROM AMONG THE REPORTED CANDIDATES.

IMPORTANT NOTE: ALL THE CONCERNED CANDIDATES ARE ADVISED TO STRICTLY ADHERE TO THE BELOW INSTRUCTIONS.

- i) The admissions/allotment of seat shall be based only on the merit of NEET UG 2021 from among the registered students subject to verification of documents and fulfillment of eligibility for allotment of seat as per the regulations of the University/Statutory Body.

NOTE:

1. Registration is Mandatory for the candidates for participating in Counselling/Admission.
2. For details, Candidates are requested to refer the Admission Brochure for Academic Session 2021-22.
3. Candidates are advised to visit regularly the University Website www.ipu.ac.in as well as the online admission website <https://ipu.admissions.nic.in> till the admission process for Academic Session 2021-22.

- ii) It is mandatory for all the candidates to attend the counselling in person at the University Dwarka Campus along with their original documents and photocopies (for retaining in file).
- iii) Candidates essentially shall produce the original certificates at the time of counselling/allotment of seat and in case he/she has taken admission somewhere else in programme other than MBBS and deposited the documents, then he/she should submit a written proof from the concerned college/institution/ university for the same. However, the seat allotment shall be as per the matrix of MCI regarding the eligibility to participate in further rounds of counselling.
- iv) Candidates shall be submitting an undertaking of not having admitted / joined any seat in MBBS consequent to the conduct of 2nd Counselling through AIQ/Deemed/or any other State Counselling etc. and such candidates shall not be granted any seat in this round of counselling. In the event, the candidate undertaking or any other document is found to be false, the admission of candidate shall be cancelled at that stage of the programme.
- v) Candidates admitted through this Counselling shall join in their allotted college till 23rd April, 2022, failing which, they shall have no claim on the allotted seats and their admission shall be treated as cancelled.
- vi) Number of tentative seats available for Stray Vacancy Round Offline Counselling is already detailed above. However, the final category wise vacant seat status, shall be displayed/announced at the counselling venue.

I. ELIGIBILITY FOR PARTICIPATION IN STRAY VACANCY ROUND:

The following category of candidate is not eligible for participation in the Stray Vacancy Round of Counselling to be conducted by GGSIPU:

- a) Who have become non-eligible due to having inadequate documents as per Eligibility Criteria.
- b) Who have not registered or did not pay the Registration Fee of Rs. 1200/- and Counselling Participation Fee of Rs. 1000/-. Candidates without mandatory registration shall not be permitted during Mop Up counselling under any circumstances.
- c) Candidates already registered with GGSIPU but have joined their MBBS seat allotted through any rounds of AIQ/Deemed University/State Counselling across the country are not eligible for participation in Mop Up Round of Counselling to be conducted by GGSIPU. Please refer Sub-Point 5, Appendix 'F' of the Medical Council of India Regulations on Graduate Medical Education, 1997 (Amended upto May, 2018)

IMPORTANT NOTE:

- a. The admission of students, who fail to fulfill the minimum eligibility criteria mentioned in the Admission Brochure or as stated by the Statutory Body or fail to produce the adequate documents for eligibility and reservation, will be cancelled.
- b. The allotment of seat of a candidate will also be cancelled, if the candidate already holds a seat in by allotment through any rounds of any State/AIQ/Deemed across the country during the session 2021-22.

NOTE: ALL THE REGISTERED APPLICANTS HAVE BEEN CALLED IN RESERVED CATEGORIES TO ENSURE NO SEAT REMAIN VACANT. HOWEVER, COUNSELLING SHALL STOP AS AND WHEN ALL THE SEATS ARE FILLED. ANY RESERVED CATEGORY OR SUB-CATEGORY CANDIDATE IS ELIGIBLE TO SECURE A SEAT IN GENERAL CATEGORY BASED ON THE RANK.

- The conversion of SC, ST, OBC to General Category shall be done only during the counselling. While converting the seats, any unfilled seat reserved for ST category will be offered to SC category and vice versa and only after completing this exercise, the conversion of the reserved category seats to General Category shall be effected. However, any OBC vacant seat shall be directly converted to General Category.
- Any, SC/ST/PWD vacant seat in ACMS, shall be converted to 'ARMY' for 'Wards of Army Personnel' after exhausting the complete list of that particular category.
- Candidates are requested to refer to the tentative seats available for Stray Vacancy Round of Counselling. All the candidates will be called accordingly to ensure that no seat remains vacant. However, the counselling shall stop as and when the seats are filled up.
- Any category candidate, which have not been called and/or whose vacancy does not depict in the 'vacancy position' may attend the counselling as an unreserved category candidate and/or the vacancy may arise consequent to the conversion of categories during Mop-round of counselling.

- x) **Character Certificate** from the head of the Institution from where the qualifying examination was passed or from Gazetted Officer (not more than 6 months old).
- xi) **SC/ ST/ OBC (NCL)/ DEF/ PWD/ EWS** etc. Certificate, whichever applicable (Original and One Photocopy).
- xii) **Medical Certificate** (as per **Appendix 6**, Admission Brochure 2021-22).
- xiii) The candidate shall have to be present in person for the purpose of verification of documents and allotment of seats as the schedule.
- xiv) **The candidate must produce original certificate for the purpose of verification of documents and allotment of seats and in case he/she has taken admission somewhere else in programme other than MBBS and deposited the documents, then he/she should submit a written proof from the concerned college/institution/ university for the same.**

VI. **REPORTING OF CANDIDATES TO THE ALLOTTED INSTITUTE/COLLEGE:**

The candidates are required to report at the respective college/institute along with the Provisional Admission Slip by **23rd April, 2022 (within the working hours of the respective college/institution)**, failing which, the admission/allotment of seat shall be automatically cancelled. The candidates may also have to pay the balance amount of fees (if any) at the respective allotted college/institute.
