JUSTICE SANJEEV SACHDEVA

- Graduated from Delhi Public School, Mathura Road, New Delhi in commerce in 1982.
- Graduated with a Bachelor of Commerce (Honors Course) in 1985 from SRI RAM COLLEGE OF COMMERCE, Delhi University.
- Got a Bachelor of Laws degree in 1988 from CAMPUS LAW CENTRE, University of Delhi. Enrolled as an Advocate with the Bar Council of Delhi on 1st August 1988.
- Attended the Commonwealth Young Lawyers Course in 1992 at the Institute of Advanced Legal Studies, University of London and worked with solicitors and barristers in England as part of the said course.
- Qualified as an Advocate On Record of the Supreme Court of India in June 1995
