In pursuance of recommendation of the CPF Board of Trustees, GGSIP University in its meeting held on 27.01.2023 and subsequent clarifications received from the Accounts Branch in consultation with Pension Fund Regulatory and Development Authority (PFRDA), all regular employees, whose cases of counting of past service are under process as per provision under Clause 3.0 of Ordinance 36, are hereby informed that they are required to open NPS Account until the matter of their counting of past service is finalized.

In this context, concerned employees are requested to submit their details in the NPS Subscriber Registration form alongwith necessary documents, i.e., copy of PAN, Aadhar & Copy of cancelled cheque of salary account (in duplicate) to Establishment Branch of the University within 15 days from the date of issue of this notice.
