Minimum 60% or equivalent in the qualifying examinations as under: B.E./B.Tech. in Chemical Engineering or equivalent

Documents Required for Verification and Allotment of Seats: 5.

- · Bank Draft(s) of Rs. 1,33,000/- (Including Rs. 1,000/- Counselling Processing Fee (one time non-refundable) in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his/her name, date of admission, phone, address, mobile no., name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s).
 - Four passport sized photographs (same as that in admit card)
 - Qualified and Valid GATE Score Card (Original), if applicable.
 - Experience Certificate (original), if applicable.
 - CET-2023 Admit Card in Original and CET 2023 Result
- · Copy of Admission verification form (Copy of Admission verification form as per Appendix 6 in Part F of Admission Brochure 2023-24.)
- Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
 - Mark-sheets / Certificates of qualifying examination:

The candidate will be required to bring the Original certificates / Marksheets of all the year wise or semester wise in original along with photocopy of Certificates / Mark-sheets of qualifying examination.

Physical Fitness Certificate:

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2023-24 (As per Appendix 5).

Reserved Category Certificate:

All reservation category candidates who are seeking admission in reserved category in UR&EWS/ SC / ST / DEF / PWD must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. The Defence Category candidates, in addition, shall also bring Appendix 1 duly completed. The Appendices are available in Part F of Admission Brochure 2023-24.

- Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- Application regarding age or any other relaxation with necessary approval (if necessary).

- The candidate claiming reservation against UR EWS category must produce certificate issued by the Competent Authority at the time of verification of documents and allotment of seat.
- 6. <u>Seat Matrix</u>: To be displayed at the time of counselling.
