- a) This is in continuation to University's Notification No. 257/2023 and 258/2023 dated 27.09.2023.
- b) Eligibility Criteria:

The candidates are required to kindly go through the eligibility criteria laid down in the Admission Brochure for Academic Session 2023-24 available on the University Website www.ipu.ac.in and Admission Website www.ipu.admissions.nic.in for a particular programme / course. Seats shall be allocated on the basis of All India basis purely (i.e. without Regional distribution (Delhi & Outside Delhi) from among the registered candidates based on final merit.

- c) The allotment of seats shall be carried out irrespective of region and category on All India basis, purely on merit of CUET.
- d) REFUND OF FEE:

The candidate will NOT be allowed for any kind of refund of fee after taking admission in this Round of Offline Counseling for Academic Session 2023-24.

- e) Documents Required for Allotment of Seats:

- g) Candidate shall mandatorily bring duly filled and signed Admission Verification form, Preference Sheet, available in the Admission Brochure 2023-24.
- h) Reporting Slip for Verification of Documents in original
- i) Bank Draft(s) of Rs. 60,000/- in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi IS REQUIRED AT THE TIME OF ALLOTMENT OF SEAT. The candidate will write his/her name, date of admission, phone, address, mobile no., name of the programme, CML Rank notified by the University and CUET Roll Number on the back of the Bank Draft(s). Balance fee has to be paid at their respective college.
- j) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- k) Mark-sheets / Certificates of qualifying examination:
 The candidate will be required to bring the Original certificates / Mark-sheets of all the year wise or

The candidate will be required to bring the Original certificates / Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates / Mark-sheets of qualifying examination.

1) Physical Fitness Certificate:

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate given in Admission Brochure 2023-24.

m) Conduct and Character Certificate from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.

- o) In Affiliated Colleges/ Institutes of GGSIPU, the balance amount of fees may be submitted as per the instructions issued by the respective Affiliated College / Institute.
