DETAILED SCHEDULE REGARDING CONDUCT OF 2ND ROUND OF OFFLINE STATE COUNSELING FOR VERIFICATION OF DOCUMENTS AND ALLOTMENT OF SEATS IN PGAC (MD/MS AYURVEDA) (CET CODE 196) IN CH. BRAHM PRAKASH AYURVED CHARAK SANSTHAN, NEW DELHI (AFFILIATED TO GGSIP UNIVERSITY) FOR THE ACADEMIC SESSION 2023-24.

This information notice is being notified for admission in '50% State Quota Seats' in MD/MS Ayurveda only for candidates who have passed BAMS degree from GGSIP University.

The procedure for "Verification of Documents" and "2nd Round of Counselling/Allotment of seat" for the above said programme is given below:

VENUE OF COUNSELLING: GGSIP UNIVERSITY, SEC 16C, DWARKA, NEW DELHI.

DATE OF COUNSELLING: 08.11.2023 (11:00 A.M.)

1. Only the candidates who have qualified AIAPGET 2023 and have passed BAMS from GGSIP University, have registered with this University and submitted their documents for verification and preparation of merit list are only eligible to participate in this Offline Counselling for 50% seats under State/Institutional Quota.

It may please be noted that the candidates who have not qualified AIAPGET 2023 and have not registered with GGSIPU or did not submit their documents for verification and preparation of merit on the specified date & time, are not eligible to participate in the counseling for allotment of seats.

- 2. Tentative merit list prepared basis on the documents submitted by the registered candidates, is already uploaded on the website along with University notification no. 281/2023 dated 12.10.2023.
- 3. The tentative vacant seat status to be filled in Round 02 under 50% State Quota is as under:
 - (I) ROG NIDAN & VIKRITI VIGYAN 01 (EWS)

The final vacancy status shall be displayed at the venue on the date of counselling.

- 4. The candidate has to be present in person for the purpose of verification of documents and allotment of seats as per the schedule. The candidate must produce original certificate for the purpose of verification of documents and allotment of seats.
- 5. SCHEDULE FOR 2ND COUNSELLING OF '50% STATE QUOTA'

1ST PHASE OF ALLOTMENT OF SEAT:

In case of vacancy arising on account of withdrawal or due to non-joining after the 1st round of counselling, the following procedure will be adopted. "From the allotted seats, from whatever roster point, the vacancy has arisen, in any particular category, then the seat shall be offered to the same category eligible candidate merit rank-wise till all eligible candidates of that category are exhausted, after which the conversion of seat shall be done as per GOI rules." In this procedure, 1st phase of 2nd round of Counselling will start from the roster point at which the first withdrawal comes from.

2ND PHASE OF ALLOTMENT OF SEAT:

Subsequently, the resultant vacancies so created and the unfilled vacant seats of 1st round of counselling, shall be offered to the registered candidates who had not opted or allotted any seat during the 1st Round of Counselling and also, those registered candidates, who were absent during 1st Round of Counselling but name figures in the Merit list uploaded on University website.

08.11.2023	All the REGISTERED CANDIDATES in person (irrespective of category), who have passed BAMS from the affiliated college of Guru Gobind Singh Indraprastha University i.e. in Ch. Brahm Prakash Ayurved Charak Sansthan, New Delhi and also qualified AIAPGET 2023 exam and their names appear in the Merit List displayed on University website on 12.10.2023.	11:00 A.M.

- Note: (1) Only the registered candidates who have passed qualifying examination i.e. BAMS from GGSIP University and submitted their documents for verification and preparation of merit list within the scheduled date & time are eligible to participate in the Offline State Quota Counselling.
- (2) All the candidates, irrespective of Rank and Categories, have been called to ensure that no seat remains vacant. However, THE COUNSELLING SHALL STOP AS AND WHEN THE SEATS AER FILLED UP.
- 6. ROSTER POINT: A separate roster shall be followed for admission on '50% State Quota seats' conducted by GGSIP University. The roster shall be continued from roster point number where the 1st counselling was closed in the Academic Session 2023-24 i.e. the Roster Point shall start from 139. However, candidates are advised to read the procedure for conduct of Round 02 counselling detailed in this schedule above.

7. GENERAL TERMS AND CONDITIONS:

The required certificate(s) for reserved categories/classes will be essential at the time of the counselling/admission and no provisional admission shall be admissible for want of caste/category certificate. Further, the caste/category certificate should invariably be in the name of the candidate himself/herself and not in favour of respective parents/guardians.

8. ELIGIBILITY CONDITION FOR PGAC PROGRAMME:

Candidates should have qualified BAMS. All candidates must appear in AIA-PGET 2023 conducted by AYUSH for the appropriate branch and qualify to be considered for admissions.

NOTE: Only the BAMS graduates passed from the medical college/institute affiliated with GGSIP University are eligible for allotment of seats under 50% State Quota (conducted by GGSIPU). The applicants who have passed BAMS from Institutes/University other than that affiliated with GGSIP University are not eligible for allotment of seats under 50% State Quota (conducted by GGSIPU).

9. QUALIFYING MARKS/CUT OFF PERCENTILE:

In order to be eligible for admission to PGAC, it shall be necessary for a candidate to obtain minimum marks of percentile in the AIAPGET 2023 as per the minimum marks of percentile mentioned in the Central Council of Indian Medicine notification which is 50th percentile for General Category, 40th percentile for SC/ST/OBC, candidate with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 (49/2016), the minimum marks shall be 45th percentile for the General Category and 40th percentile for the Scheduled Caste, Scheduled Tribe and Other Backward Classes

9. AGE LIMIT AND AGE RELAXATION: Refer Admission Brochure 2023-24.

10. GUIDELINES FOR CANDIDATES CLAIMING RESERVATION UNDER PH/PWD CATEGORY:

The guidelines regarding admission of students with "Specified Disabilities" under the Rights of person with disability Act, 2006 (49 of 2016) in PGAC shall be applicable as provided in the Central

Council of Indian Medicine (CCIM), New Delhi notification dated 24th July, 2021 respectively available under public domain on the CCIM & CCH website.
