The Ministry of Home Affairs, Government of India has decided to approve to introduce a new category 'G20 Talent Visa' under sub-category (S-5 visa) of Student Visa for Scientists, Researchers, Faculty members, Scholar and Academicians of the G20 group countries to enter India for the purpose of projects, training programs, post-doctoral research, fellowships, etc.
