MBBS – EXTENDED STRAY VACANCY ROUND 2023-24

Consequent to the notice dated 31.10.2023 uploaded by the Office of MCC, DGHS, Govt. of India and subsequent to the cancellation of admission of 01 candidate in Delhi General PWD category at Dr. BSA Medical College & Hospital, the University hereby notifies an Extended Stray Vacancy Round of Counselling in MBBS programme for the session 2023-24 with detailed instructions for candidates

NOTE:

Candidates are advised to refer the information/instructions detailed in the Admission Brochure published and uploaded by the University and also refer to the information's detailed in the Information Bulletin of MCC, DGHS for the session 2023-24.

All counseling shall be held according to the directions of the Statutory Regulatory body, Govt. of India, Govt. of NCT of Delhi, Hon'ble Court(s) and/or the University.

THE UNIVERSITY SHALL CONDUCT THE EXTENDED STRAY VACANCY ROUND THROUGH OFFLINE MODE FOR ADMISSION IN MBBS ON THE BASIS OF MERIT FROM AMONG THE NEET UG 2023 QUALIFIED CANDIDATES WHO HAVE REGISTERED WITH THE GGSIP UNIVERSITY AND HAVE ALSO PAID THE FEE OF RS. 1500/- AND RS.1000/- AND NEITHER HAVE BEEN ALLOTTED SEAT NOR DO THEY HOLD ANY SEAT ALLOTTED UNDER AIO/DEEMED/CENTRAL/AIIMS/JIPMER/STATE QUOTA ACROSS THE COUNTRY.

THE CANDIDATES MUST READ THE SCHEDULE CAREFULLY. THIS SCHEDULE CONTAINS THE DATE AND TIME FOR REPORTING OF CANDIDATES IN PERSON AT THE COUNSELLING VENUE FOR VERIFICATION OF DOCUMENTS AS WELL AS VERIFICATION OF ELIGIBILITY AND THEREAFTER FOR ALLOTMENT OF THE SEATS.

THE UNIVERSITY SHALL DECLARE CLOSURE OF THE EXTENDED STRAY VACANCY ROUND COUNSELLING AS AND WHEN ALL THE VACANT SEATS ARE FILLED UP IN ORDER OF MERIT FROM AMONG THE CANDIDATES REPORTED FOR ALLOTMENT OF SEAT.

IMPORTANT NOTE: ALL THE CONCERNED CANDIDATES ARE ADVISED TO STRICTLY ADHERE TO THE BELOW INSTRUCTIONS

i) The admissions/allotment of seat shall be based only on the merit of NEET UG 2023 from among the registered eligible students subject to verification of documents and fulfillment of eligibility for allotment of seat as per the regulations of the University/Statutory Body.

- 1. Registration is Mandatory for the candidates for participating in Counselling/Admission.
- 2. For details, Candidates are requested to refer the Admission Brochure for Academic Session 2023-24.
- 3. Candidates are advised to visit regularly the University Website www.ipu.ac.in as well as the online admission website https://ipu.admissions.nic.in till the admission process for Academic Session 2023-24.

- ii) It is mandatory for all the candidates to attend the counselling in person at the University Dwarka Campus along with their original documents for verification and photocopies for retaining the same in admission file.
- iii) Candidates essentially shall produce the original certificates at the time of counselling/allotment of seat. The allotment of seats shall be as per the instruction laid down in the Information Bulletin and notices uploaded by the Medical Counselling Committee (MCC), DGHS, Govt. of India regarding the eligibility to participate in this round of counselling.
- iv) Candidates shall be submitting an UNDERTAKING of not having been admitted / joined any seat in MBBS consequent to the conduct of Counselling through AIQ/Deemed/or any other State across the country etc. and such candidates shall not be granted any seat in this round of counselling. Candidates who will be allotted seat in this round of Counselling conducted by the University are advised to ensure that the Undertaking submitted by them at the time of allotment is true and bonafide. In the event or at a later stage, if the Undertaking is found to be false or incorrect, the candidate himself/herself shall be responsible for cancellation of his/her admission and the University shall not be responsible for the loss of the allotted seat in the University or both the institutions.
- v) Candidates admitted through this Counselling shall join in their allotted college till 15th November 2023 (Last date of joining) mandatorily.
- vi) Notice uploaded by the Office of MCC, DGHS, Govt. of India vide ref. U-11011/01/2023-MEC dated 31.10.2023, states:

Candidates who are not holding any seat either in All India Quota or State Quota are eligible to participate in Special Stray Vacancy Round. However, candidates who did not join their seats allotted through MCC Round-3 onwards are 'Not Eligible' to participate.

The Deposit of candidates who do not join their allotted seat in Special Stray Vacancy Round will be forfeited and such candidates will be debarred from taking NEET exam for the next year.

- vii) Number of tentative seats available for Stray Vacancy Round Offline Counselling is already detailed above. However, the final vacant seat status shall be announced at the counselling venue.
- I. ELIGIBILITY FOR PARTICIPATION IN EXTENDED STRAY VACANCY ROUND: The following category of candidate is NOT ELIGIBLE for participation in the Extended Stray Vacancy Round of Counselling to be conducted by GGSIPU:
 - a) Who have become non-eligible due to having inadequate documents as per Eligibility Criteria.
 - b) Who have not registered or did not pay the Registration Fee of Rs. 1500/- and Counselling Participation Fee of Rs. 1000/-. Candidates without mandatory registration shall not be permitted under any circumstances.
 - Candidates registered with GGSIPU and have been allotted seat through any rounds of AIQ/Deemed University/State Counselling across the country are not eligible for participation in this Round of Counselling to be conducted by GGSIPU.

IMPORTANT NOTE:

- The admission of students, who fail to fulfill the minimum eligibility criteria mentioned in the Admission Brochure or as stated by the Statutory Body or fail to produce the adequate documents for eligibility and reservation, will be cancelled.
- b. The allotment of seat of a candidate will also be cancelled, if the candidate already holds a seat in by allotment through any rounds of any State/AIQ/Deemed across the country during the session 2023-24.

- → ALL THE REGISTERED ELIGIBLE APPLICANTS HAVE BEEN CALLED TO ENSURE NO SEAT REMAIN VACANT. HOWEVER, COUNSELLING SHALL STOP AS AND WHEN ALL THE SEATS ARE FILLED. ANY RESERVED CATEGORY OR SUB-CATEGORY CANDIDATE IS ELIGIBLE TO SECURE A SEAT IN GENERAL CATEGORY BASED ON THE RANK.
- → Candidates are requested to refer to the tentative seats available for Extended Stray Vacancy Round of Counselling. All the candidates will be called accordingly to ensure that no seat remains vacant. However, the counselling shall stop as and when the seats are filled up.
- → Any category candidate, which have not been called and/or whose vacancy does not depict in the 'vacancy position' may attend the counselling as an unreserved category candidate and/or the vacancy may arise consequent to the conversion of categories during Mop-round of counselling.
- IV. FEES TO BE PAID AT THE TIME OF COUNSELLING/ALLOTMENT OF SEAT:
 A candidate will have to mandatorily bring a Demand Draft of Rs. 60000/- in the name of REGISTRAR,
 GURU GOBIND SINGH INDRAPRASTHA UNIVERSITY, payable at DELHI. Balance fees, if any, shall be paid by the candidate directly in the respective allotted college.

- xiv) The candidate must produce original certificate for the purpose of verification of documents and allotment of seats.

VI. REPORTING OF CANDIDATES TO THE ALLOTTED INSTITUTE/COLLEGE:

The candidates are required to report at the respective college/institute along with the Provisional Admission Slip latest by 15th November 2023 (within the working hours of the respective college/institution). The candidates may also have to pay the balance amount of fees (if any) at the respective allotted college/institute.

Note: As stated in the Information Bulletin of MCC, if a candidate is allotted a seat in Extended Stray round, he/she has to join the allotted seat/college. If the candidate does not join the allotted seat, he/she shall be debarred from NEET examination for 01 Year along with forfeiture of fees.

- a. The admission of students, who fail to fulfil the minimum eligibility criteria mentioned in the Admission Brochure or as stated by the Statutory Body or fail to produce the adequate documents for eligibility and reservation, will be cancelled.
