Note: As approved by Finance Committee vide Agenda Item No. 64.11, subsequently approved in the 80th Meeting of Board of Management of GGSIP University vide Agenda Item No. 80.34, notified vide no. F. No. GGSIPU/Coord/80th BOM/2023/928 dated 30.11.2023 that "The Board of Management considered and approved the levy of separate Examination Fee @ Rs. 3,000/- per student / per annum from the Academic Session 2024-25." In addition to this Innovation and Incubation Fee of Rs. 500/- to be paid by all the students of USSs and Affiliated Institution every year from the Academic Session 2024-25, as approved in 65th Finance Committee meeting held on 2th December, 2023.

- Four passport sized photographs (same as pasted in admit card)
- CET original Admit Card of CET-2024.
- Proof of Date of Birth (secondary school of Mark-Sheet & Certificate): Original and self-attested photocopy.
- Mark-Sheet/Certificate of qualifying examination. The candidate will be required to bring the Original Certificate/Mark-Sheets of all the year wise or semester wise in original alongwith photocopy of certificates/marks-sheets of qualifying examination.
- Physical Fitness Certificate- All the students shall be required to submit a medical certificate indicating fitness a Registered Medical Practitioner as per format given in the admission Brochure 2022-23.
- Reserved Category Certificate

All reservation category candidates who are seeking admission in reserved category in SC,

ST and EWS must bring their reservation certificate in original alongwith the self attested photocopy of the certificate for claiming seat against the reserved category.

The Provision for reservation in OBC category is not applicable for Post Graduation/Master Level programmes. However, the OBC category candidates shall claim seats in General Category in the order of their rank as per merit, as their respective regions.

8. Conduct and Character Certificate in original from the Head of the Institution form where the qualifying examination has been passed or from Gazetted officer in original, not more than 06 (six) months old.
9. Application regarding age or any other relaxation with necessary approval (If necessary):

It is the sole responsibility of the candidates to make sure that they fulfil the eligibility conditions laid down in the GGSIP University Admission Brochure for the Programme for Session 2024-25. If at any stage, it is found that the candidates does not fulfil the requisite eligibility conditions, his/her admission will stand cancelled and disciplinary action will be initiated against him/her and his/her entire fee will be forfeited.
