No other person in place of the candidate shall be allowed to submit the documents for taking admission on the behalf of the candidate. 5.	Withdrawal of admission	Candidates are advised to take a calculated decision of continuing in Third round as they would not be permitted to resign from 3 <sup>rd</sup> round. They will also not be allowed to participate in any Counselling after joining in 3 <sup>rd</sup> Round. There will be Data sharing between Centre and the States and if any candidate has his name in the list of allotted candidates in either of the lists, then such name of such candidates shall be eliminated from Stray Vacancy Round.	

The conversion of seats will be carried out during the Round 3. The said conversion will be done only when the eligible Candidates belonging to the said Conversion Category have exhausted.

Criteria for participation in Round 3 online counselling by the University:

- Candidates who registered for Round 1 or Round 2 and did not get any seat allotted are not required to register again.
- Fresh New Registration Round 3 for those candidates who:
  - Have not registered in Round-1 or Round 2 (with full payment of fees; Registration and Counselling Participation Fee).
  - Have Resigned / Not reported in Round-1 or Round 2 need to fill fresh choices only with full payment of fees
- Exercising of "Fresh Choice filling" and Locking of choices.
- Process of Seat Allotment Round-3
- Publication of result of Round 3 on University website.

**NOTE:**

- Choice Filling is mandatory for allotment of seats in Online Counselling. If you don't register and fill in choices during registration period, you will not be allotted any seat.

- f) Physical Reporting with original documents at the allotted Medical/Dental College against Round 3 allotted seat.
- g) If upgraded, the candidate must take relieving from Round 2 seat and join Round 3 seat. Once joined, he cannot upgrade or resign from this seat.
- h) If allotted a seat in Round 3, a candidate who does not report at the allotted college will exit with forfeiture of fee deposited and will get eliminated from further rounds of counselling. Also, after Round 3, if a candidate is allotted a seat, he/she will not be eligible in Stray Vacancy Round.
- i) Who are not eligible for 3<sup>rd</sup> Round of allotment?  
 (a) Candidate who has become non-eligible due to having inadequate documents as per Eligibility Criteria  
 (b) Who have not registered in Round 1 or Round 2 or Round 3.

**Note:**

1. If a candidate freshly registered in round 3 is not allotted a seat, he/she is eligible to participate in stray round.
2. Candidates getting upgraded in Round 3 shall NOT have any claim on Round 2 seat.

**Detailed Schedule for Stray Vacancy Round Counselling, if required, will be notified on or after 24.10.2024.**

**I. GENERAL INSTRUCTIONS:**

- (a) The candidates must read the conditions of eligibility for admission as given in the Admission Brochure for 2024-25 carefully and must satisfy themselves regarding their eligibility for admission in various programmes before registering online for admission and submitting the Counselling Participation Fees.
- (b) It is the sole responsibility of the candidate to ensure that they fulfill the minimum eligibility criteria in the programmes they seek admission; the correctness of the details filled with respect to region; category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or false the admission to the programme shall be cancelled and all the fees paid will be forfeited.
- (c) In order to avoid last minute rush, the candidates are advised to apply early enough. The University will not be responsible for network problems or any other problem of such nature for either submission of online application or any other activity during the last minute.
- (d) Candidates claiming seat in Delhi region must have passed the qualifying (11<sup>th</sup> and 12<sup>th</sup>) examination from any school/college located in Delhi only. Allotment of seats in wrong region on account of incorrect filling of form will lead to cancellation of the allotment at any later stage and candidate will automatically lose the right to the seat in his/her bonafied region if not available at the time of cancellation of seat.
- (e) Any other terms and conditions as defined by the Statutory body/Competent Authority, shall be applicable for counselling process/admission to MBBS programme for academic session 2024-25. In the event of any provision mentioned in the Admission Brochure being found to be at variance with any binding regulation/directions of any statutory body, then the higher norms will prevail.

**II. REPORTING/JOINING OF CANDIDATES TO THE ALLOTTED INSTITUTE/COLLEGE:**

- i) The candidates allotted seat, have to report to their respective allocated nursing colleges/institutions for verification of documents pertaining to qualifying exam eligibility, reserved category certificate, NEET UG 2024 score card, etc and payment of balance Part Academic Fee as per the Offer letter of result of Round 03 of Online Counselling.
- ii) After allotment of seat in the Round 03 of Counselling, the candidate, if he/she has made the payment of Part Academic Fee of Rs. 96,000/-, can generate Provisional Admission Slip.
- iii) Proof of payment of Part Academic Fee receipt of Rs. 96,000/- is available in the candidate's profile within the stipulated period.
- iv) The candidates are required to report and join the respective medical colleges/institutions with the Provisional Allotment Letter and the necessary record for verification of documents at the college and



pay the balance amount of fees (if any), as per the schedule mentioned above, failing which the admission shall be automatically cancelled.

- v) The institutions shall submit/share data of the joined candidate (as per NIC online portal) to the University as well as to the MCC, DGHS, by 24.10.2024. The vacant/unallotted seats after the round 02 of Online Counselling and seats vacant due to non-reporting of candidates and subsequent withdrawal of admissions shall be considered for Round 03 Counselling.
- vi) All admissions shall be provisional till regularized by the University. **PROVISIONAL ADMISSION WILL NOT BE DONE FOR ANY RESULT AWAITED OR COMPARTMENT / SUPPLEMENTARY CASES.**
- vii) Institutes are required to submit a certificate within two days to the Admission Branch after the reporting schedule of a particular Round of counselling stating that all documents (i.e. qualifying exam eligibility, reserved category certificate, NEET UG 2024 score card) of allotted candidates in their USS/Institute have been verified and they are found eligible (including remaining part academic fees) and thereafter all the candidates after a particular round of counselling have been shown reported on the NIC portal by the concerned USS/Institute and that there is not even a single Student being allowed to attend classes who has not been allotted any seat after a particular round of counselling.


Candidates who report to the allotted institutions and are reflected in the list submitted by the institutions as reported/admitted, shall be called "admitted students".
