Dear Ms. Atishi Marlana ji,

As you may be aware, the PM Internship Scheme (PMIS), has been announced as part of the Budget on July 23rd, 2024 with the important and ambitious objective of providing internship opportunities to one crore youth in the next 5 years, in the top 500 companies of the country. The aim of this scheme is to provide an opportunity to the youth to get training, gain experience and skills within the real-life environment of the business or organization, in turn assisting enhancement of her/his employability.

As an initiation, a pilot project targeting 1.25 lakh youth, in the age group of 21-24 years, who are not engaged in full time education or full-time employment has been launched on 03rd October, 2024.

Under this pilot project, every selected intern will receive a monthly allowance of Rs. 5000 (out of which Rs. 4500 is to be paid by the Ministry of Corporate Affairs, and Rs. 500 by the company from its CSR funds) as monthly allowance, along with Rs. 6000 as a one-time grant for incidentals, to be paid by the Ministry of Corporate Affairs. The detailed guidelines of the Pilot Scheme have been communicated to your State/ UT.

The Scheme is being implemented through an online portal, www.pminternship.mca.gov.in. On the said portal, Companies have offered more than 1.27 lakh opportunities across different sectors covering 745 districts across all States/ UTs including yours. The eligibility criteria for the different opportunities span across high school, higher secondary, ITI certificate holders and diploma holders and graduates. Currently, the Portal is opened up till 10th November, 2024 for youth to make their applications by giving 5 preferences based on their choice. At the national level so far more than 2.5 lakh applications have been received.

In this regard, I would like to draw your attention to the letter written by Secretary, Ministry of Corporate Affairs to the Chief Secretary of your State/ UT earlier this month. The officers of this Ministry have been in touch with the officers of your State and have highlighted the opportunities available in each and every district of the State against which the youth can apply. Further, the eligible youth may also apply against opportunities available in other States/ UTs as per their preference.
