Role: Legal interns

Location: Moolchand Healthcare, Lajpat Nagar, New Delhi.

Duration of the Internship: 6 months.

Following the internship, based on their performance, students may be made an offer for full-time employment with Moolchand Healthcare.

Eligibility: Final year students in the last phase of graduation/post-graduation as well as fresh graduates fulfilling the conditions below-

- Class X and XII scores must be 70% or more
- Law Graduates - meeting the academic thresholds wanting a role in a corporate environment where there will be a mix of 20-30% law and the remaining on other aspects of the organization
- A high degree of comfort with technology and aptitude to pick up the use of tech tools quickly on the job
- Exceptional performers from other disciplines willing to join the Healthcare industry and meeting the minimum academic criteria can also apply

Stipend: ₹15,000/- pm (Rupees Fifteen Thousand only per month) shall be paid as stipend during the internship period.

Working hours: 09:00am-06:30pm six days a week (may extend a bit in case of time-sensitive work)

Other information: The selected students will get the opportunity to work very closely with the MD of the company and will get significant real-world learning experience with a potential job at the other end of the internship

Selection process and subsequent steps:

1. Application on above link
2. Shortlisting of the profiles and send list of questions for the shortlisted students to record and respond to on a video
3. Moolchand will share the final shortlist
4. Moolchand will then have a 30-minute orientation call with the selected students over Zoom. At this stage, culture and role expectations will be shared. The students will be given an option to drop out at this stage if they feel that the role is not a fit for them.
5. The date of joining will be shared with the remaining candidates.
6. Within the tenure of the internship, an offer of employment will be made to students who Moolchand Healthcare wishes to employ. The others will be given a letter of experience for the internship.
