- i) The admissions/allotment of seat shall be based only on the merit of NEET UG 2023 from among the registered students subject to verification of documents and fulfilment of eligibility for allotment of seat as per the regulations of the University/Statutory Body.
- ii) It is mandatory for all the candidates to attend the counselling <u>in person</u> at the University Dwarka Campus along with their original documents and photocopies (for retaining in file).
- iii) Candidates essentially shall produce the original certificates at the time of counselling/allotment of seat. However, the seat allotment shall be as per the norms of AYUSH regarding the eligibility to participate in counselling.
- iv) Candidates shall be submitting an undertaking of not having allotted/admitted/joined any seat in UG (BAMS/BSMS/BUMS/BHMS) COURSES consequent to the conduct of Counsellings through AIQ/Deemed/or any other State Counselling etc. across the country and such candidates shall not be granted any seat in this round of counselling.
- v) Candidates who will be allotted seat in this round of Counselling conducted by the University are advised to ensure that the Undertaking submitted by them at the time of allotment is true and bonafide. In the event or at a later stage, if the Undertaking is found to be false or incorrect, the candidate himself/herself shall be responsible for cancellation of his/her admission and the University shall not be responsible for the loss of the allotted seat in the University or both the institutions.
- vi) CANDIDATES ADMITTED THROUGH THIS COUNSELLING SHALL JOIN/REPORT TO THEIR ALLOTTED COLLEGE TILL 18TH NOVEMBER, 2023
- vii) Number of tentative seats available for this Round of Counselling is already detailed above. The final category wise vacant seat status shall be displayed/announced at the counselling venue.
- I. <u>ELIGIBILITY FOR PARTICIPATION IN STRAY VACANCY ROUND FOR BAMS & BHMS PROGRAM</u>:
 - All registered candidates who have not been admitted to any of the seats through AACCC-UG
 counseling or counseling conducted by State/UTs are eligible for Stray Vacancy Round.

- (A) Thereafter, the conversion of vacant seats of SC, ST, OBC to General Category shall be done. While converting the seats, any unfilled seat reserved for ST category will be offered to SC category and vice versa and only after completing this exercise, the conversion of the reserved category seats to General Category shall be effected. However, any OBC vacant seat shall be directly converted to General Category.
- (B) Candidates are requested to refer to the tentative seats available for Stray Vacancy Round Counselling. All the candidates will be called accordingly to ensure that no seat remains vacant. However, the counselling shall stop as and when the seats are filled up.
- (C) Any category candidate, which have not been called and/or whose vacancy does not depict in the 'vacancy position' may attend the counselling as an unreserved category candidate and/or the vacancy may arise consequent to the conversion of categories during Mop-round of counselling.
- f) CUT-OFF percentile and score as per order/directions of Ministry of AYUSH.

IV. FEES TO BE PAID AT THE TIME OF COUNSELLING/ALLOTMENT OF SEAT:

A candidate will have to mandatorily bring a Demand Draft of Rs. 60000/- in the name of <u>REGISTRAR</u>, <u>GURU GOBIND SINGH INDRAPRASTHA UNIVERSITY</u>, payable at <u>DELHI</u>. <u>Balance fees, if any, shall be paid by the candidate directly in the respective allotted college</u>.

NOTE: Candidates who were allotted seat through Round 01, Round 02 and Round 03 Online Counselling in programs BAMS & BHMS conducted by the University during the academic session 2023-24 and paid the Part Academic Fee of Rs. 60,000/-, however, he/she did not report at the allotted college or have subsequently withdrawn their admission need to submit the another demand draft of Rs. 60,000/- for allotment of seat in this round of Offline Counselling at the counselling venue.



- The admission of students, who fail to fulfil the minimum eligibility criteria mentioned in the a. Admission Brochure or as stated by the Statutory Body or fail to produce the adequate documents for eligibility and reservation, will be cancelled.
- b. NO PROVISIONAL ADMISSION WILL BE DONE FOR ANY RESULT AWAITED OR COMPARTMENT / SUPPLEMANTARY CASES.
- c. Registration is mandatory in the respective Programme/Course for participating in Counselling/Admission.
- d. Candidates are advised to visit regularly the University Website www.ipu.ac.in as well as the online admission website https://ipu.admissions.nic.in till the admission process for Academic Session 2023-24 concludes.
- e. Conduct of Counselling (including verification of documents & allotment of seats) shall be held offline in the University campus.
- f. The University will not consider any claim for allotment of seat in the reserved category on the basis of any undertaking. If any such candidate's claim has been inadvertently verified and he/she manages to secure a seat, during physical verification of documents at the time of counselling/allotment of seats, reporting at the allotted college or thereafter, at any stage, the admission shall be cancelled and the entire fee shall be forfeited.
