

## Schedule For Special Opportunity for Admission in B.A. in Liberal Arts Programme Based on the Merit of Respective CET Followed by CUET

**Venue of Counselling: Guru Gobind Singh Indraprastha University  
Sector 16 C, Dwarka, New Delhi -110078.**

1. This is to inform all the candidates that the Special Round of Offline Counselling will be carried out for the Seats Remained Vacant after Reporting of candidates, withdrawal of admissions, cancellation of allotted seats, un-allotted seats and non-reporting candidates in University School of Liberal Arts in B.A. Liberal Arts (CET Code 451) Programme during the Academic Session 2024-25.
2. **Allotment of Seats:**
  - (a) **The allotment of seats shall be carried out irrespective of region and category on All India basis. Allotment of seat shall be in the Order of Priority of applicable CET/NLT and CUET.**
  - (b) **First priority will be given to respective NLT/CET (whichever applicable) Candidates for filling up of vacant seats. After exhausting CET/NLT applicants, the remaining seats will be offered to the CUET candidates in the order of merit.**
  - (c) **Merit List for CUET Candidates shall be uploaded after Physical Verification of Documents.**
3. The conduct of the Special Round of OFFLINE Counselling is to facilitate those candidates only who have not been able to get admission for certain reasons in the Counselling Process held so far. During the special Round of OFFLINE Counselling, the University shall ensure that allotment of seats is purely on merit basis.
4. **It will also be the sole responsibility of the candidate to ascertain and make sure that he/she possesses the requisite eligibility and qualifications prescribed for admission in the programme. The candidates MUST go through the prescribed Eligibility conditions and Admission criteria as laid down in this Admission Brochure for 2024-25.**

5. **Fee to be deposited at the time of counselling :**

The following fee shall be paid by the candidates at the time of counseling in the form of a demand draft in favour of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi, as per the details given below :-

(a) **IT IS MANDATORY TO BRING THE DEMAND DRAFT OF APPLICABLE FEE, AS DETAILD ABOVE, AT THE TIME OF COUSNELLING.**

(b) The candidate will write his/her name, date of admission, phone, address, mobile no, name of the programme, CET/NLT/CUET Rank and Roll Number on the back of the Bank Draft(s).

- vi. Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)



- vii. **Mark-sheets / Certificates of qualifying examination:** The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
- viii. **For Distance / Open Learning Cases:** In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.
- ix. **Physical Fitness Certificate:** All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2024-25 (As per Appendix 5).
- x. **Result Awaited:** candidates seeking admission as result awaited candidate must have to submit Appendix 4 of Part F of Admission Brochure 2024-2025.




