

6. **Verification of documents to determine Merit:** All the registered candidate whose name appeared in the list enclosed (programme wise) and had paid Registration fees of Rs 2,500/- (non refundable), shall report in person, for verification of documents for preparation of Rank wise Common Merit list.
7. **Eligibility Criteria**
The candidate are required to kindly go through the eligibility criteria laid down in the Admission Brochure for Academic Session 2023-2024 available on the University Website www.ipu.ac.in and Admission Website www.ipu.admissions.nic.in for a particular programme/course
8. Merely registrations by paying participation fee of Rs. 2500/- in this Round towards above mentioned University notification in this regards, does not **guarantee** an admission
9. **Documents required for verification:**
 - (a) Registration Form for the session 2023-24 (Self attested)
 - (b) Proof of Date of Birth (Secondary School Mark-sheet and Certificate) (**Original and Photocopy**) (Self Attested).
 - (c) **Mark-Sheet/Certificates of qualifying examination:**
The candidate will be required to bring the Original certificates / Mark - sheet of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination. (Self attested)
 - (d) Copy of CUET Score Card 2023. (Self attested)
 - (e) Copy of reserved category certificate, if any.

Important Note:

- (a) It will also be the sole responsibility of the candidate to ascertain and make sure that he/she possesses the requisite eligibility and qualification prescribed for admission in various programmes. The candidates **MUST** go through the prescribed Eligibility condition and Admission criteria as laid down in this Admission Brochure for 2023-2024.
- (b) It is made very clear that only, and only the candidates who had appeared in CUET are eligible to register online on the University portal. Any candidate who has appeared in University's Common Entrance Test (CET) are not eligible to register and participate in the counselling that shall be conducted based on the CUET score.

After the document verification, the eligible candidates are required to deposit Rs.1,02,000/- (Rupees One Lakh Two Thousand only) through Demand Draft only, drawn in favour of Registrar, Guru Gobind Singh Indraprastha University, for completing the process of admission.
