### Eligibility criteria

Candidates are required to have a B.Tech (Biotechnology/Chemical Engg/ Biochemical Engg/or related field), B. Pharma or MSc (in Biotechnology/Biochemistry or related field of life and natural sciences) with a minimum of 60% (General, EWS & OBC category) or 55% (SC,ST & PwD) marks.
