This is with reference to the subject mentioned above. Vide Judgement dated 26.09.2023 (available on the website of Labour Department, GNCTD), Hon'ble Supreme Court of India in civil Appeal No. 7175/2021, titled "CPL Ashish Kumar Chauhan (Retd.) Vs. Commanding Officer & Ors. has directed Secretary (Labour) of every state to ensure collection of information and data relating to compliance with sections 19 and 20 of HIV Act, 2017 in regard to designation of a complaint officer, in all the factories, industrial establishment, commercial establishment, shops, plantations, commercial offices, professional organizations, and all other bodies falling within the definition of "establishments" (under section 2(f) of the HIV Act) which reads as follows:

"establishment" means a body corporate or co-operative society or any organization or institution or two or more person jointly carrying out a systematic activity for a period of twelve months or more at one or more places for consideration or otherwise, for the production, supply or distribution of goods or services."

You are therefore, requested to kindly ensure compliance with sections 19 and 20 of HIV Act, 2017 in Educational Institutions within your jurisdiction and send the compliance report to Dr. Jitender Mann, Inspector of Factories, GNCTD (Nodal Officer), D-Block 5-Sham Nath Marg, Civil Lines within 03 weeks.
