- 1. This is in continuation to University's Important Notification No. 24/2025, IPU-7/Academic/2025-26/409 dated 30.04.2025 titled 'IMPORTANT NOTIFICATION Regarding Extension of Last Date for Submission of Online Application Form for the Academic Session 2025-26'.
- 2. Candidates are directed to go through the General Important Instructions for claiming the seats earmarked for various Reserved Categories uploaded on University Website vide Notification No. 30/2025, F.No.IPU-7/DI (Academic)/Misc./2025/456 dated 13.05.2025.
- 3. Candidates are also directed to refer to the <u>Indicative Procedure for Verification of Documents of All the Allotted & Part Academic Fee Paid Candidates (Online Counselling) Post Verification for Academic Session 2025-2026 dated 28.05.2025</u> uploaded on the University admission portal https://ipu.admissions.nic.in.
- 4. It is to inform to all the JEE MAIN PAPER I 2025 qualified candidates that the CORRECTION/ EDIT Window (for already registered candidates) along with FRESH REGISTRATION (who have not yet registered) in the program BACHELOR OF TECHNOLOGY (B.TECH) (CODE 131) has been scheduled to start detailed as below:

- 5. Candidates who fall under sl. no. 1 of the above table can correct/edit their filled application form specifically their Category, Sub-Category, Region (passed qualifying examination i.e. class XII from any school / college located in Delhi or Outside Delhi) and JEE Main Paper I 2025 Rank for allotment of seat in their claimed Region/ Category/ Sub-Category. The candidates have to upload copy of their Educational Testimonials, Reserved Category Documents and JEE MAIN PAPER I 2025 Score card.
- 6. Uploading of documents and/or correction in Online Application Form can be done by the candidate through his/her account Login given during the registration process.
- 7. It is reiterated, to claim reservation of Defence Sub-Category Seat, candidates are required to mark their Sub-Category DEFENCE "YES", Otherwise candidates, who have marked their Sub-Category DEFENCE "NO" will not be able to claim reservation/allotment of seats entitled for DEFENCE Sub-Category. Further, the candidates opting for Defence Sub-Category are also required to select the 'PRIORITY' of Defence they belong to and upload the relevant APPENDIX-

- 1, duly filled and signed by the Competent Authority, along with supporting documents, failing which their claim shall not be considered as valid.
- 8. Since the result of Class 12th /Qualifying Exam has been declared, JEE MAIN PAPER I 2025 qualified candidates must upload the marksheet of their class 12 / qualifying examination, for ascertaining the eligibility of their securing a seat. It is also mandatory to upload the valid Reserved Category Certificates towards their claim of seat. In the absence of valid / correct documents, the seat so secured on the basis of claimed Category / Region shall be jeopardized.
 - With regard to Result Awaited candidates, it is made clear that who have 'compartment' as on date in his qualifying examination, will not be considered for admission. They should seek provisional admission only due to non declaration of result of final year/final semester of the qualifying examination by Board/University and not on account of compartment in current or previous years of qualifying degree examination as on date of admission. Result Awaited candidates may please see the provisions contained in Chapter 3 of Part A and Appendix-4 of Admission Brochure for Bachelors Programme).
- Candidates are advised to re-check and/or correct/ edit their filled application form specifically their Category, Sub-Category and Region (as per Last Qualifying Examination) for allotment of seat in their claimed Region/ Category/ Sub-Category.
- 10. This is for information of all the stakeholders that the data of JEE (Main) received from the NTA, it was found that there were number of candidates are at common ranks. In order to, get Unique Rank of each candidate, the University adopted the criteria which is given as below to arrive at a unique Rank:

"In case All India Rank Common Rank List (CRL) Rank of the candidate in the JEE (Main) 2025 examination as given by NTA is not unique, ad unique rank will be generated for each candidate for allotment of seats using the following parameters in the order mentioned below applicable for all the participating Universities/Institutes.

- 1) JEE Main rank
- 2) Date of Birth (person with age greater to be given preference)
- 3) Random draw process in case the tie still persists."

The above said criteria have also been adopted by the Joint Admission Committee (JAC) Delhi 2025.

- 11. It is the sole responsibility of the candidate to ensure that they fulfill the minimum eligibility criteria in the program they seek admission; the correctness of the details filled with respect to Region; Category/Sub-Category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or false, the admission in the programme shall be cancelled and all the fees paid will be forfeited.
