**ORDER**

In pursuance to University Circular No GGSIPU/COF/2013/600 dated 1<sup>st</sup> February, 2013 and in furtherance of the GGSIP University Medical Attendance Treatment Regulations 2000 (Revised) circulated vide order dated 15.07.2016, vide which, the terms and conditions of the Memorandum of Understanding (MoU) for empanelment of Hospitals, Dental & Eye Centres and Diagnostic Centres under the aforesaid regulation in cashless and non-cashless category were circulated.

The Pushpanjali Medical Centre has responded to the above communication and submitted signed MoU agreeing to the terms and conditions of the University, to provide the medical treatment to the employees of the University and their dependent family members on CGHS rates. 
