# INTRODUCTION

Legal Aid Centre (LAC) of GGSIPU works towards access of justice for disempowered and marginalized segments of society since 2002. It has approval from Delhi State Legal Service Authority (DSLISA) and has Visits of DSLISA Empanelled Lawyer on every Thursday. In the backdrop of poverty and inequality, legal aid is an effective step towards attainment of the ideals of 'social, economic and political' justice that are enshrined in our Constitution under the Directive Principles of State Policy

The importance of legal aid and awareness campaigns as a mechanism for social progress is something that has been repeatedly stressed upon by the Government of India. Legal Aid Centre has mission to strive to perform our duty by imparting legal awareness and promoting community consciousness through social outreach and service initiatives, awareness drives, informational meetings and donations, connecting the society at all fronts to and for those who are starving for legal assistance and perspiring with a hope for just an avenue for access to justice

It regularly conducts internship programs for law students on a PAN Delhi basis to train them in legal aid services, make them understand the opportunities, issues and challenges and inculcate amongst them service and pro bono attitude.

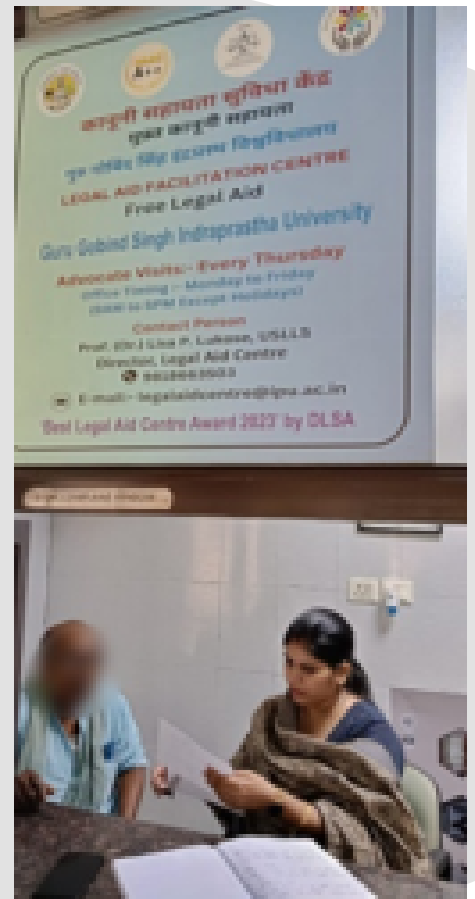
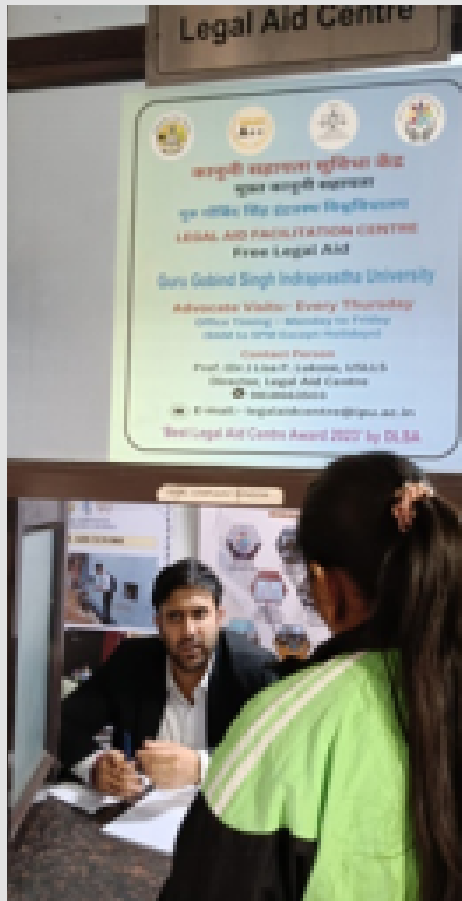
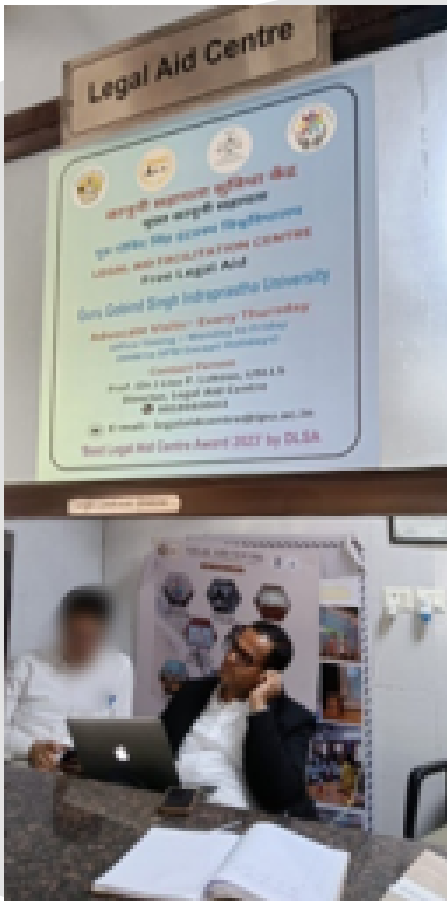

# 1. LAWYERS WEEKLY VISIT

Every Thursday, a lawyer from DLSA visits the Legal Aid Facilitation Centre, GGSIPU and gives legal advice to the poor people who are in need of legal assistance who visit the centre. In the past 12 months, the centre has assisted more than 800 people who approached the centre. ## 2. SCHOOL OUTREACH PROGRAM, GOVERNMENT CO-ED SR. SEC. SCHOOL, DWARKA

On 10.04.2024, a team from the Legal Aid Centre, GGSIPU visited the Government co-ed Senior Secondary School under the guidance and supervision of the Legal Aid Director. The purpose of the visit was to educate the students about the importance of education beyond the 12th grade and to provide guidance on various career options available to them. Furthermore, the students were introduced to a diverse range of career options spanning across different fields, including but not limited to, law, engineering, medicine, humanities, and commerce. The team elucidated on the skill sets and qualifications required for each profession, empowering the students to make informed decisions about their future endeavours.







### 3. SCHOOL OUTREACH PROGRAM AT GOVERNMENT GIRLS SENIOR SECONDARY SCHOOL, VILLAG PAPRAWAT

On April 16, 2024, a team from the Legal Aid Cell of USLLS, GGSIPU visited the Government Girls Senior Secondary School, Paprawat to spread awareness among school students about the prospects of their careers and their legal rights and duties. Prof.(Dr.) Lisa P. Lukose and Prof. (Dr.) Kanwal D.P. Singh guided the students on the value of education and how it can help them to be independent in life. The students were informed about the significance of continuing their education journey beyond the 12th grade, with insights into how higher education unlocks numerous opportunities such as better-paying jobs, career progression, and personal satisfaction. Various academic pathways post-12th grade, including undergraduate programs, vocational courses, and professional certifications, were discussed in detail.





## 4. PARA LEGAL VOLUNTEERS TRAINING PROGRAMME BY DSLSA

The Legal Aid Centre (LAC), University School of Law and Legal Studies (USLLS), Guru Gobind Singh Indraprastha University (GGSIPU) under the auspicious of Delhi State Legal Service Authority (DSLISA) conducted a Para Legal Volunteer (PLV) Training program on 19th and 20th of April 2024 at GGSIPU Dwarka campus. The PLV programme was meant for those students who found qualified for the training through the interview conducted by South West DSLISA. The DSLISA trained 127 students from the University School of Law and Legal Studies, GGSIPU, and Maharaja Surajmal Institute, an affiliated college of the IP University.

The learned judicial officers from the central and South West offices of DSLISA gave rigorous training to the selected trainees which included 8 technical sessions covering vital legal topics.

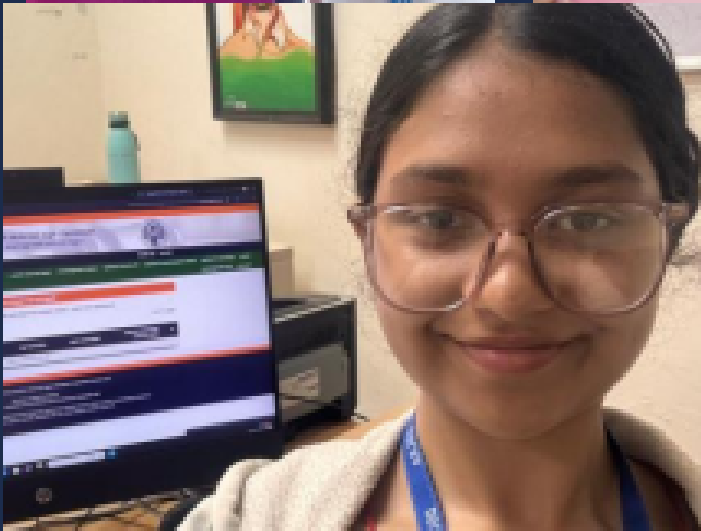






## 5. ACTIVITIES OF PARA LEGAL VOLUNTEER'S

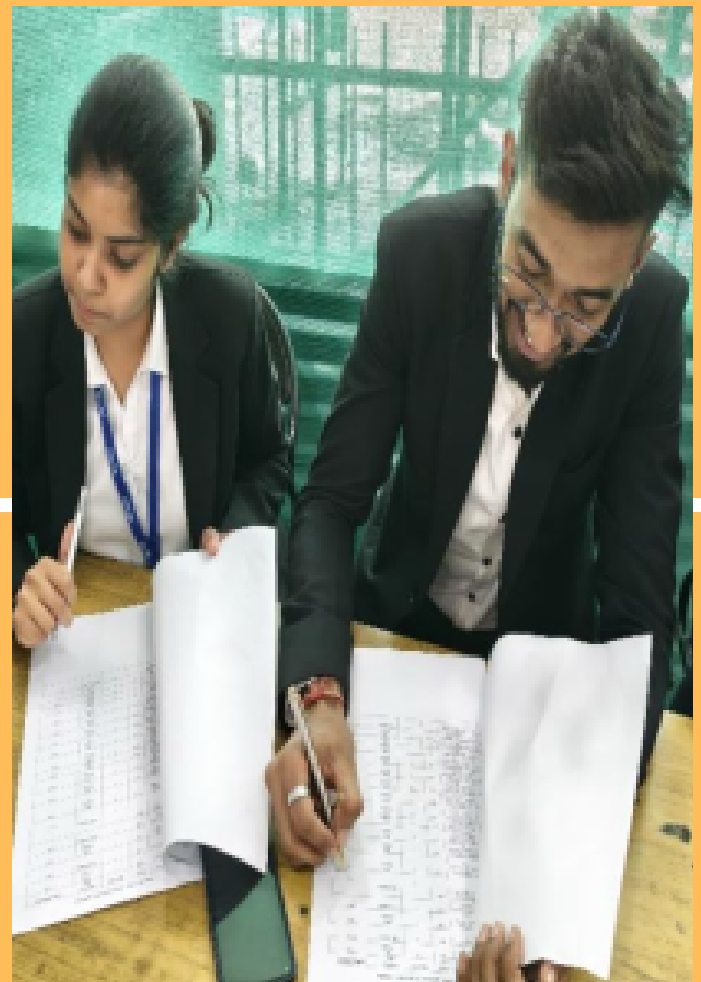

The event was graced by the esteemed presence of Hon'ble Mr. Justice K. V. ## 6. MIGRANT AND ASYLUM PROJECT

The MAP Asylum Project organized an extensive training program for students of Guru Gobind Singh Indraprastha University (GGSIPU) in Delhi, aimed at equipping them with critical skills and knowledge to support asylum seekers. Conducted in April and May, the MAP Asylum Project recently organized an extensive training program for students of Guru Gobind Singh Indraprastha University (GGSIPU) in Delhi, aimed at equipping them with critical skills and knowledge to support asylum seekers. The curriculum was meticulously designed to cover a broad spectrum of topics essential for asylum advocacy. It included detailed modules on international refugee laws, the rights of asylum seekers, and the procedural intricacies involved in filing for asylum. Specific sessions focused on sexual and gender-based violence (SGBV), highlighting its prevalence among asylum seekers and strategies for support and intervention. The program included labor laws education, emphasizing asylum seekers' workforce rights and addressing employment issues. Sessions on socio-cultural dimensions featured refugee accounts, enriching students' empathy and understanding. Practical training included discussions and assignments on filing police complaints, crucial for handling SGBV and other crimes. The program concluded with feedback and a certification ceremony, where students shared their insights and praised the MAP Asylum Project's approach. The training was a resounding success, benefiting the students and enhancing their ability to support asylum seekers.





## 7. SUMMER INTERNSHIPS

The Legal Aid Centre conducted a summer internship programme from 01.07.2024 to 31.07.2024 for Law students of Delhi. 13 Students from various law schools were selected. During the internship period, the students researched and learnt in-depth knowledge about topics such as (i) Legal Aid as a Constitutional Right in India, (ii) Three new criminal law legislations which India has enforced from 1 July 2024, (iii) Artificial intelligence and Law, (iv) Data protection, Right to Privacy and Cyber security in Cyber Space and specific Case Studies relating to Speedy Justice and Legal Aid along with Fieldwork.







## 8. NUKKAD NATAK DURING STUDENT INDUCTION PROGRAMME

A compelling street play was performed by first and second year students during the orientation of various student cells for first-year students on 12th August 2024. The play was organized by the Legal Aid Cell which centered around the theme 'failing an exam does not define one's worth, and turning to drugs as a coping mechanism is never a solution.' The performance guided the audience through relatable scenarios that students often face like academic pressure, fear of failure, and the following emotional turmoil. The play was well-received by the audience, many of whom were moved by the realistic portrayal of the issues and the hopeful resolution presented. ## 10. PARTICIPATION OF STUDENTS AT LOK ADALAT



On September 7, 2024, a team of first years accompanied by two research scholars were guided by Adv. Aman, member, DLSA about the proceedings of three major courts and even responded to their queries arising in the expedition.

The students learnt about the alternate dispute resolution process in Traffic matters, complaints against Municipal Corporation, Delhi and crimes pertaining to Section 188 of I.P.C. One of the judges of the Lok Adalat explained the students about the morality of the profession and the impact it brings to the society. He, further, made the students acquainted of the mercifulness expected in a Lok Adalat and the various types of acute punishments assigned to the lawbreakers like fines.





## II. SAKSHAM 3.0

Project Saksham 3.0 was conducted from September, 2024 to January, 2025 under the faculty coordination of Prof. (Dr.) Lisa P. Lukose of USLLS, GGSIPU. The initiative was a collaborative effort involving the University of Delhi, IP University, Jamia Hamdard, NEK Mission Foundation, and Naksh Foundation. It was conducted across more than 18 locations in Delhi, including areas such as Khanpur dhani, Mukharjee Nagar, Shamshan Basti, Shiv basti, Kirti Nagar (Railway Track), Shamshan basti, Najafgarh Road Industrial area, Seemapuri, Rangpuri Pahadi, Vikaspuri, Mansarovar, Madanpur Khadar, Kathpulti Colony, Mandi Colony, Mahatma Gandhi DDA Camp, Rajeev Gandhi DDA Camp, Punjabi Bagh DDA Camp and Indira camp Vikaspuri.





## 12. LEGAL LITERACY AND OUTREACH PROGRAMME AT SDMC BOYS SCHOOL POCHANPUR

The village of Pochanpur has been adopted by GGSIP University, and the Legal Aid Centre, GGSIPU, has been given permission to visit and offer services in the village during the second week of September. Prof. (Dr.) Lisa P. Lukose, Director of Legal Aid, and Prof. (Dr.) Kanwal D. P. Singh, Former Director of the Legal Aid Centre, met with principals of the government schools in the village on September 4th 2024, to discuss the necessary procedures for interacting with students and to find out what subjects the students needed to be enlightened on. They are both registered volunteers under the Vidyanjali program of the Education Department of Delhi government, and they have conducted sessions under Vidyanjali.

On September 9th, 2024, a team from the Legal Aid Cell of USLLS, GGSIPU visited the S.D.M.C. Pochanpur Boys School under the supervision and guidance of Dr. Lisa P. Lukose and Dr. Kanwal D.P. Singh in pursuance of their meeting dated September 4th, 2024. The purpose of the visit was to educate the students about ways in which they can enhance their personality and be a good citizen, inculcate positive attitude in them and make them aware about their legal rights and duties.





## 13. DOOR TO DOOR CAMPAIGN AND VILLAGE OUTREACH PROGRAMME AT POCHANPUR

The village of Pochanpur has been adopted by GGSIP University, and the Legal Aid Centre, GGSIPU, has been given permission to visit and offer services in the village during the second week of September. Prof. (Dr.) Lisa P. Lukose, Director of Legal Aid. and Prof. (Dr.) Kanwal D. P. Singh, Former Director of the Legal Aid Centre, contacted the Pradhan of the village and took up the charge to provide free legal advice to the villagers.

On September 12, 2024, a team from the Legal Aid Cell of USLLS, GGSIPU visited the Pochanpur Village. To aid us in this novel program, Advocate Virendra Rathi and Advocate Shitanshu Dhar Pathak from Dwarka Court set up a free legal aid help desk with us at the Village Community Centre. The purpose of this initiative was to inform the villagers about their legal rights, duties, beneficial schemes and policies of the Government and provide them with legal advice and guidance for their personal conundrums.





## 14. STREET PALY PERFORMED BY STUDENTS AT BHARAT VIHAR MARKET AREA

The Legal Aid Centre at USLLS, GGSIPU, conducted an impactful nukkad natak in the Bharat Vihar Market area on September 26, 2024. The visit to the area was aimed at raising legal awareness through active role-playing. The nukkad natak emphasised on the repeated injustices faced by women and how such forms of injustices are ignored due to their wide prevalence in society, economic issues or even gender biases.

The nukkad natak performed by the student members of the Legal Aid Centre at USLLS, GGSIPU, proved to be impactful, with active observation of the play by various inhabitants of the area. The play attracted the older people, the adults and the children alike. The Centre put another step forward towards its wider aim of ensuring that legal awareness reaches the remotest of areas and continues to work towards achieving its aim.







## 15. NUKKAD NATAK PERFORMED BY STUDENTS IN NAJAFGARH AREA

On 10th October 2024 the Legal Aid centre at USLLS, GSSIPU Main campus performed a nukkad natak tackling the stigma surrounding menstruation, aiming to normalize discussions about periods among all genders.

The performance conveyed that menstruation should not be shrouded in secrecy or shame. It addressed the health risks associated with improper menstrual hygiene and emphasized the importance of using safe sanitary products.





## 16. ONLINE QUIZ COMPETITION ON WORLD MENTAL HEALTH DAY

The Legal Aid Centre (LAC) at USLLS, in collaboration with the Internal Complaint Committee (ICC) of Guru Gobind Singh Indraprastha University, hosted an Online Quiz Competition on 14th October 2024 to mark World Mental Health Day. The theme for this year's event, "It is time to prioritize mental health," aimed to remind students about the importance of taking care of their mental well-being. The quiz was intended not only to test knowledge but also to create space for important discussions about mental health and how it affects our everyday lives. The competition was held online, making it accessible to students across different courses. It was open to all undergraduate, postgraduate, and research students, allowing for a diverse group of participants. The quiz itself consisted of 30 multiple-choice questions, with a time limit of 15 minutes. The questions touched on different aspects of mental health, from general awareness to self-care and emotional resilience. It was a great opportunity for students to reflect on how mental health plays a role in their lives, especially in the demanding environment of university life.

## 18. LEGAL HELP DESK AT ANNUAL CULTURAL FEST, GGSIPU

The Legal Aid Centre of University School of Law and Legal Studies (USLLS), in collaboration with the Delhi State Legal Services Authority (DSLA), set up a Legal Helpdesk at Anugoonj, the annual fest of Guru Gobind Singh Indraprastha University, from 24th February to 26th February. ## 19. LEGAL AID STALL AT SILVER JUBILLEE CULMINATION PROGRAMME OF GGSIPU



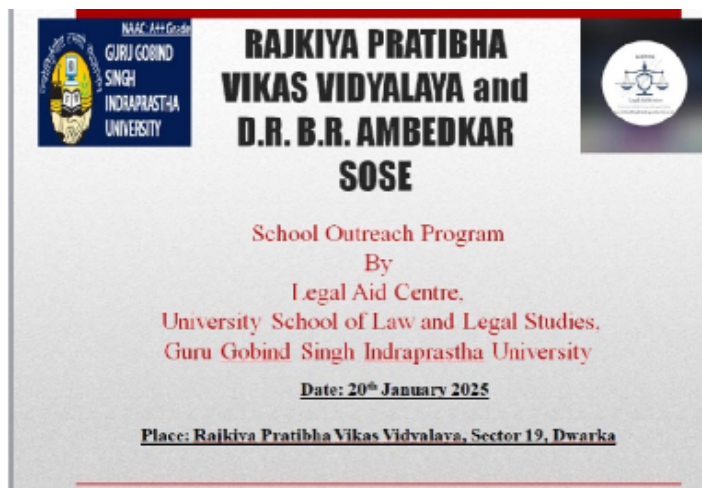
