**PROCEEDINGS OF THE HEARING No. XIII**

A hearing of Admission Regulatory Committee (ARC) under the Chairmanship of Sh. S.N. Sahai, IAS (Retired) was held on 3<sup>rd</sup> June, 2025 at 04:30 p.m. at Conference Hall, Room No. 216, Admin Block, Indira Gandhi Delhi Technical University for Women, Kashmere Gate, Delhi-110006 to deliberate upon grievances/representations/complaints received from aspiring candidates/parents/other stakeholders.

Secretary, HE/TTE (Member Secretary, ARC), extended welcome to the Chairman and Committee Members.

In the beginning, Registrar (GGSIPU) gave following updates on the ongoing Admission Process for the year 2025-26:-

1. **Applications Received**: Approximately 1,13,000 applications have been received.
2. **Correction windows** : Correction windows have been opened for students to get their details verified and corrections to be made, if required.
3. **Counseling Process**: Counseling for over 8 programs have commenced, with others to follow soon.
4. **Approvals**: College-wise approvals for Provisional NOCs for the session 2025-26 have been sent to the Government, with some approvals already received.
5. **New Courses**: New courses have been introduced for the upcoming academic year.
6. **Fee Structure**: SFRC meetings have been conducted to finalize institute fees.

Further, regarding Management Quota Admissions, it was informed that:-

1. **NIC IDs and Passwords**: University has issued NIC IDs and Passwords to all the affiliated Institutes for document upload, ensuring compliance with DPCI Acts and court orders.
2. **Compliance**: Meetings of all affiliated Institutes have been conducted in University and they have been instructed to adhere to Management Quota (MQ) admissions formalities.
3. **Monitoring**: The University will monitor compliance and ensure adherence to Regulations.

**The Chairman and members of the Admission Regulatory Committee (ARC) directed that to ensure a smooth, transparent, and fair Management Quota (MQ) admission process following additional steps be taken :-**

1. **Compliance with DPCI Rules**: All affiliated Institutes must comply with Rule 8 of DPCI Rules, 2007 in true spirit and **Registrar, GGSIPU to ensure compliance by all Institutes and a report be submitted to the ARC.**
2. **Transparency**: For the information of parents and students, all affiliated Institutes and University websites must ensure display of DPCI Act & Rules at prominent place for information of all stakeholders and to ensure transparency in Management Quota admissions.
3. **Technical Check**: To develop a system to ensure proper functioning and monitoring of websites of affiliated Institutes during the admission process so that stakeholders may use websites without any hassles, such as slow speeds or crashes, to prevent difficulties for students. **The Registrar, GGSIPU to ensure that this must be regularly checked. The VC, IGDTUW, has been requested to oversee this.**
4. **Display of Applicant List**: Affiliated Institutes must display the list of all applicants with requisite details, including those who applied online and offline so that proper transparency may be ensured.
5. **Provisional Merit List**: The final merit list should be displayed only after all Online & Offline applications have been displayed and the students have been given the opportunity to verify the same on the website. After the verification period is over, a rank-ordered merit list be displayed/uploaded.

Thereafter, with the Chair's approval, a PowerPoint presentation outlining group-wise complaints was presented before the Committee. After thorough deliberation, decisions were made, and the following directives were issued: -


