- It is to inform to all the CLAT UG 2025 qualified candidates that the CORRECTION/ EDIT window along with FRESH REGISTRATION in the program INTEGRATED BA-LL.B. (HONS.)/ INTEGRATED BA-LL.B & INTEGRATED BBA- LL.B. (HONS.)/ INTEGRATED BBA -LL.B (CODE 121) (CLAT UG 2025) has been scheduled to start detailed as below:

- 3. Candidates who have already filled the online Application form, paid the requisite Non-Refundable application fee of Rs. 2500/- can correct/ edit their filled application form specifically their Category, Sub-Category and Region (passed qualifying examination i.e. class XII from any school / college located in Delhi or Outside Delhi) for allotment of seat in their claimed Region/ Category/ Sub-Category. The candidates have to upload copy of their Educational Testimonials, Reserved Category Documents and CLAT UG 2025 Score card.
- 4. Uploading of documents and/or correction in online application form can be done by the candidates through their account login id and password created during the registration process.
- 5. It is reiterated, to claim reservation of Defence Sub-Category Seat, candidates are required to mark their Sub-Category DEFENCE "YES", Otherwise candidates, who have marked their Sub-Category DEFENCE "NO" will not be able to claim reservation/allotment of seats entitled for DEFENCE Sub-Category. Further, the candidates opting for Defence Sub-Category are also required to select the 'PRIORITY' of Defence they belong to and upload the relevant APPENDIX-1, duly filled and signed by the Competent Authority, along with supporting documents, failing which their claim shall not be considered as valid.

With regard to RESULT AWAITED CANDIDATES, it is made clear that who have 'COMPARTMENT' as on date in his qualifying examination, will not be considered for admission. They should seek provisional admission only due to non declaration of result of final year/final semester of the qualifying examination by Board/University and not on account of compartment in current or previous years of qualifying degree examination as on date of admission. Result Awaited candidates may please see the provisions contained in Chapter 3 of Part A and Appendix-4 of Admission Brochure for Bachelors Programme).

- Candidates are advised to re-check and/or correct/ edit their filled application form specifically their Category, Sub-Category and Region (as per Last Qualifying Examination) for allotment of seat in their claimed Region/ Category/ Sub-Category.
- 8. It is the sole responsibility of the candidate to ensure that they fulfill the minimum eligibility criteria in the program they seek admission; the correctness of the details filled with respect to Region; Category/Sub-Category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or false, the admission in the programme shall be cancelled and all the fees paid will be forfeited.
- Candidates are directed to go through the General Important Instructions for claiming the seats earmarked for various Reserved Categories uploaded on University Website vide Notification No. 30/2025, F.No.IPU-7/DI (Academic)/Misc./2025/456 dated 13.05.2025.
