Schedule for "Preparation of Merit" for the Programme D.Pharm (Code 190) in Centre of Excellence in Pharmaceutical Sciences, GGS Indraprastha University : Academic Session 2025-26

The candidates must read the complete Schedule and ensure their presence.

1. All the candidates, who have registered and submitted the Online application form and paid the requisite application fee of Rs.2500/-, shall report in person 'verification of documents' FOR PREPARATION OF MERIT at the venue on the above mentioned date and time.

2. **Eligibility Criteria.** To pursue D. Pharm. course one must have passed the 10+2 examination or equivalent with a minimum of 50% aggregate marks in the Science stream PCB or PCM (Chemistry, Physics, Biology or Mathematics). The minimum age to pursue the D. Pharmacy eligibility is minimum 17 years as on date 31.12.2024 and the candidates must possess valid certificates of passing an examination and relevant qualifying examination to get enrolled in D. Pharmacy. Admission in D. Pharmacy would be on merit basis of the marks obtained in the qualifying examination.

3. **Method of Selection and admission.**

- Based on the marks obtained in the qualifying examination, the University will prepare a list of candidates in order of merit. **THE MERIT LIST WILL BE DISPLAYED ON THE UNIVERSITY WEBSITE ON 01.07.2025.**
- Admission on seats of different categories will be made on the basis of the result of the qualifying examination (12th class).
- The inter-se-merit of candidates securing equal aggregate marks at the qualifying examination will be determined according to the following criteria :-
 - The candidates getting higher marks in PCM or PCB shall rank higher.
 - In case of a tie above, the candidate older in age shall rank higher.

4. Documents required at the time of reporting for "Preparation of Merit" on 30.06.2025 :-

- Copy of Registration Form

- Copy of 12th Class marksheet
- Copy of reserved category certificate, if/whichever is applicable, for which the candidates aspire to claim against respective seats.


