OPENING OF CORRECTION/ EDIT WINDOW ALONG WITH FRESH REGISTRATION AND MANDATORY UPLOADING OF EDUCATIONAL TESTIMONIALS, RESERVED CATEGORY DOCUMENTS & CLAT PG 2025 SCORE CARD ACADEMIC SESSION 2025-26

1. This is in continuation to University's Important Notification No. 24/2025, IPU-7/Academic/2025-26/409 dated 30.04.2025 titled '**IMPORTANT NOTIFICATION - Regarding Extension of Last Date for Submission of Online Application Form for the Academic Session 2025-26**'.
2. Candidates can correct/ edit their filled application form specifically their Category, Sub-Category and Region (passed qualifying examination from any school / college located in Delhi or Outside Delhi) for allotment of seat in their claimed Region/ Category/ Sub-Category. The candidates have to upload copy of their Educational Testimonials, Reserved Category Documents and CLAT PG 2025 Score card.
3. Uploading of documents and/or correction in online application form can be done by the candidate through his/her account login given during the registration process.
4. It is reiterated, to claim reservation of Defence Sub-Category Seat, candidates are required to mark their Sub-Category DEFENCE "YES", Otherwise candidates, who have marked their Sub-Category DEFENCE "NO" will not be able to claim reservation/allotment of seats entitled for DEFENCE Sub-Category. Further, the candidates opting for Defence Sub-Category are also required to select the 'PRIORITY' of Defence they belong to and upload the relevant APPENDIX-1, duly filled and signed by the Competent Authority, along with supporting documents, failing which their claim shall not be considered as valid.
5. All CLAT PG 2025 qualified candidates must upload the marksheet of their qualifying examination, for ascertaining the eligibility of their securing a seat. It is also mandatory to upload the valid Reserved Category Certificates towards their claim of seat. In the absence of valid / correct documents, the seat so secured on the basis of claimed Category / Region shall be jeopardized.

With regard to **Result Awaited candidates**, the candidate shall give documentary proof of having appeared in the last semester/year of qualifying examination. They should seek provisional admission only due to non declaration of result of final year/final semester of the qualifying examination by Board/University and not on account of compartment in current or previous years/semester of qualifying degree examination as on date of admission. Result Awaited candidates may please see the provisions contained in Chapter 3 of Part A and Appendix-4 of Admission Brochure.

6. Candidates are advised to re-check and/or correct/ edit their filled application form specifically their Category, Sub-Category and Region (as per Last Qualifying Examination) for allotment of seat in their claimed Region/ Category/ Sub-Category.
7. **It is to inform to all the CLAT PG 2025 qualified candidates that the CORRECTION/ EDIT window along with FRESH REGISTRATION in the program MASTER OF LAW (LL.M.) (CODE 112) (CLAT PG 2025) has been scheduled as detailed below:**


