## OPENING OF CORRECTION/ EDIT WINDOWALONGWITH FRESH REGISTRATION AND MANDATORY UPLOADING OF EDUCATIONAL TESTIMONIALS, RESERVED CATEGORY DOCUMENTS & CLAT PG 2025 SCORE CARD ACADEMIC SESSION 2025-26

- 1. This is in continuation to University's Important Notification No. 24/2025, IPU-7/Academic/2025-26/409 dated 30.04.2025 titled 'IMPORTANT NOTIFICATION Regarding Extension of Last Date for Submission of Online Application Form for the Academic Session 2025-26'.
- Candidates can correct/edit their filled application form specifically their Category, Sub-Category
  and Region (passed qualifying examination from any school / college located in Delhi or Outside Delhi) for
  allotment of seat in their claimed Region/ Category/ Sub-Category. The candidates have to upload
  copy of their Educational Testimonials, Reserved Category Documents and CLAT PG 2025 Score
  card.
- 3. Uploading of documents and/or correction in online application form can be done by the candidate through his/her account login given during the registration process.
- 4. It is reiterated, to claim reservation of Defence Sub-Category Seat, candidates are required to mark their Sub-Category DEFENCE "YES", Otherwise candidates, who have marked their Sub-Category DEFENCE "NO" will not be able to claim reservation/allotment of seats entitled for DEFENCE Sub-Category. Further, the candidates opting for Defence Sub-Category are also required to select the 'PRIORITY' of Defence they belong to and upload the relevant APPENDIX-1, duly filled and signed by the Competent Authority, along with supporting documents, failing which their claim shall not be considered as valid.
- 5. All CLAT PG 2025 qualified candidates must upload the marksheet of their qualifying examination, for ascertaining the eligibility of their securing a seat. It is also mandatory to upload the valid Reserved Category Certificates towards their claim of seat. In the absence of valid / correct documents, the seat so secured on the basis of claimed Category / Region shall be jeopardized.
  - With regard to Result Awaited candidates, the candidate shall give documentary proof of having appeared in the last semester/year of qualifying examination. They should seek provisional admission only due to non declaration of result of final year/final semester of the qualifying examination by Board/University and not on account of compartment in current or previous years/semester of qualifying degree examination as on date of admission. Result Awaited candidates may please see the provisions contained in Chapter 3 of Part A and Appendix-4 of Admission Brochure.
- Candidates are advised to re-check and/or correct/ edit their filled application form specifically their Category, Sub-Category and Region (as per Last Qualifying Examination) for allotment of seat in their claimed Region/ Category/ Sub-Category.
