

NOTICE

Subject: Upgradation/Change of Stream of the students admitted in 1st Semester in the Academic Session 2025-26 in the B.Tech (Engineering programme) on the basis of their performance in 1st semester. Upgradation/ Change of Branch will be effective w.e.f. the 3rd semester which will commence from the Academic Session 2026-27.

1. The students of B.Tech Engineering Programme studying in University Schools of studies, affiliated Colleges/ Institutes of Guru Gobind Singh Indraprastha University, who will be promoted to the third semester in the Academic Session 2026-27 are hereby informed that the process of Upgradation / Change of Branch is being initiated by the University and the Upgradation/ Change of Branch will be within the same School/Institute and same shift wherever two shifts are functional.
2. **The students who have been declared not eligible to appear in term-end examination of 1st semester (detained) are not eligible for consideration under the provisions of the Regulation titled "Regulation with respect to change of Branch/Upgradation of Students in Engineering Degree Programs/B.Tech in the Third Semester of Studies in the University School of studies (USS) and Affiliated Institutes/College of GGSIP University". In addition, students should have completed all the credits prescribed in the first semester of their studies, in their first attempt, without having had to pass any course requirement in the supplementary examination.**
3. The Change of Branch/Upgradation of Students in Engineering Degree Programs in the Third Semester of Studies shall be strictly based on the common merit list of the students (without making any branch-wise differentiation) **prepared on the basis of SGPA obtained by the student in the First Semester Examinations conducted by the University.** It shall strictly be based on the University School/USS-wise, Institution wise, and shift wise criteria. Students studying in one institution/USS shall be considered for a change of branch/upgradation only within the same institution/USS and the same shift. That is, there will be no change in the institution/USS or shift in which the student was originally admitted in the first semester.
4. The University shall offer the unfilled vacancies from the previous Year/Academic Session of the First Year B.Tech. Programme (Programme Code 131). Additionally the vacant seats arising from students whose admission has been cancelled or who have withdrawn their admission in the First year upto 31st March, 2026 shall also be offered for Change of Branch/Upgradation of Students in Engineering Degree Programs in the Third Semester of Studies. No request for cancellation/withdrawal of admission of students, and thereby the addition of vacant seat(s) for change of branch/upgradation, shall be entertained from any School/Institute after the stipulated date, i.e, 31st March, 2026 as communicated vide University's email dated 20.03.2026. The Dean/ Director/ Principal of the University School/ affiliated college / institute are required to forward the details of vacant seats in Engineering Degree Programme as on 31/03/2026 for the 3rd semester to the Director-Incharge (Academic) by 15/04/2026 on the prescribed format.

5. The students of second semester (B.Tech) who will be joining 3rd Semester in the session 2026-27 and are desirous of Upgradation/Changing their Branch in the Engineering Programme, within the same institute and same shift may apply to the Dean/Director/Principal of the concerned University School of Studies/ Institute in the proforma enclosed latest by 30/04/2026. The intending eligible students shall apply using the prescribed form alongwith a duly notarized affidavit of Rs. 10/- attested by the Public notary (specimen attached). The application fee for upgradation will be Rs.2,000/- (non refundable).
- 5(a) The Deans/Director/Principal of the University Schools/affiliated colleges/institutes shall be responsible to upload the list of candidates who have applied for Upgradation/ Change of Branch on their official website on 01.05.2026.
- 5(b) The Deans/Director/Principal are required to forward in a prescribed format a compiled list of all applicants alongwith the applications of the students seeking Upgradation/Change of branch to the University and also required to provide a certificate stating that all details filled in by the students in the application forms including annexures and affidavits enclosed by the candidates, the hard and soft copies provided by the Institute to the University have been verified and certified by the concerned Dean/Director/Principal.
- 5 (c) The Deans/Directors/Principal of the University School/affiliated college/ institute shall forward the consolidated list alongwith the original copy of applications (hard copy as well as soft copy) to the office of Director Incharge (Academic) latest by **04:00 pm of 01.05.2026**.
- 5 (d) The concerned Dean/Director/Principal of the affiliated institutes/USS shall deposit the total fees per candidate @ Rs. 2000/- for change of branch/upgradation, received from the interested eligible candidates, into the University account through online mode or Challan and required to enclose the payment details/proof alongwith with consolidated list of the candidates.
6. The complete list of applications received in the University will be displayed on the University website tentatively on 07/05/2026. The result of the upgradation/change of branch/programme will be notified latest by 28/05/2026 on the University's Website: www.ipu.ac.in.
7. It is also informed that under no circumstances, those who have once applied for Upgradation/ Change of Branch and have been subsequently upgraded to any Branch/ Stream as per the options exercised by the candidate shall be allowed to withdraw their application. All changes of branch will be final and binding on the applicants.
8. Under no circumstances single application or part list for Upgradation/ Change of Branch shall be accepted in the Academic Branch No applications will be entertained/accepted for change of branch after the last date, i.e, 30.04.2026.

9. The upgradation/change of Branch shall be carried out as per "Regulation with respect to change of Branch/Upgradation of Students in Engineering Degree Programs/B.Tech in the Third Semester of Studies in the University School of studies (USS) and Affiliated Institutes/College of GGSIP University" notified by the University vide Notification No. 11/2025; GGSIPU/Academic/upgradation/2025-26/303 dated 07.04.2025 (available on the University website). The students are advised to go through the said Regulation for detailed information.
