3. Age relaxation, in respect of SC/ ST/ OBC/ Persons with benchmark Disabilities (PwBD)/ Ex-Serviceman candidates etc. and regular government employees will be as per rules.
4. Modifications, if any, pertaining to this advertisement like qualifications, interview dates, requisite documents etc. will be uploaded and updated on University website. The Candidates are advised to visit University website www.ipu.ac.in time to time.
5. In case of large number of applications, candidates will be shortlisted based on their Academic Research Score/ Experience etc. as decided by the University and University may adopt any mode of test.
