The successful bidder will be responsible for collecting the aforementioned quantities of Papers /Used Answer Books etc. from GGSIP University, Dwarka, New Delhi. The successful bidder will be required to complete the work within the time frame given in the order	The clause 13.11 is amended as under: The material shall be further cut (1/4th size of A4 paper) by the successful bidder before loading on the truck. The said cutting will be performed during the working hours of the University. The successful bidder will be responsible for collecting the aforementioned quantities of Papers /Used Answer Books etc. from GGSIP University, Dwarka, New Delhi during working days in working hours. The successful bidder will be required to complete the work within the time frame given in the order.

The last date and time of uploading the technical and financial bid on e-procurement website which was 04.02.2026 up to 2:00 p.m. has now been **extended up to 09.02.2026.**


