The Members of the Finance Committee took note of the action taken on the proceedings of the 63<sup>rd</sup> meeting of the Finance Committee held on 23<sup>rd</sup> December, 2022.

#### Agenda Item No. FC-64.03:

To consider and approve the Annual Accounts of the University for the Financial Year 2022-2023.

The members were informed about the preparation of Annual Accounts as per the Government prescribed formats and review of the same by Internal Auditor of the University viz. M/s I.P. Pasricha & Co.

In the course of discussion, it was suggested by Sh. Ravinder Kumar, Dy. Secretary, Finance, GNCTD that in future it is better to prepare the footnote also with regard to major changes / classifications in the Annual Accounts for the better understanding of the components of Annual Accounts.

After deliberations, the Members considered and approved the Annual Accounts of the University for the Financial Year 2022-23.

### Agenda Item No. FC-64.04:

To consider and approve the Revised Estimates 2023-2024 and Budget Estimates 2024-2025.

The Controller of Finance explained the salient features of the Budget duly mentioning the increase/decrease in the estimated / projected recurring and non-recurring expenditure and the provisions made viz-a-viz the total estimated / projected income.

In the course of discussion, it was pointed out by Ms. Usha Suresh that the projection of estimates for 2024-25 should be more realistic taking into account the expenditure incurred and the University School of Studies / Departments who are not utilizing their allocated budget on time, should be reviewed and their budget should be curtailed accordingly in the next year. Ms. Usha Suresh also suggested that the Department should pace out their expenditure in a given financial year instead of utilizing it only in the last quarter of the year.



After detail deliberation, the Members considered and approved the Revised Estimates 2023-2024 and Budget Estimates 2024-2025.

Agenda Item No.FC-64.05:

To apprise the Finance Committee about the C&AG Audit Report on the Annual Accounts of the GGSIP University for the Financial Year 2021-22 and comments of the University on the audit observations.

In the course of the discussion, Ms. Usha Suresh has advised to initiate special drive for bank reconciliation with the bank officers with regards to major amount pending in the reconciliation and also suggested to receive the payments on digital mode instead of accepting physical cheques. For which, Sh. Sunil Kumar Sobti, Advisor (Finance) informed that University has already started accepting payment through digital mode from the year 2022-23 and receipt of payments through cheques has been stopped.

Further, the UGC Letter No. F.25-1/2018(PS/MISC.) dated 28th January, 2019 for other conditions like appointment, qualification, selection procedure etc. shall also be followed while appointing Visiting / Guest Faculty in the University."

Agenda Item No.64.09: To consider and approve creation of Non-teaching posts (i) Chief Engineer (01 post) (ii) Sports Officer (02) posts and (iii) Veterinary officer (01 Post on contract basis) for both Campuses of the University.

The Hon'ble Vice Chancellor informed the Members of the Finance Committee that East Campus, Surajmal Vihar has been functional and in near future more infrastructure activities are to be developed in both the campuses East Delhi, Surajmal Vihar, Delhi and Dwarka, therefore, a post of Chief Engineer (on deputation) to supervise the all such kind of infrastructure activities on both the campuses, two posts of Sports Officer (on deputation) for both the Campuses to promote the sports activities and one post of Veterinary Officer (on Contract) for Animal House in CEPS are required to be created for the proper functioning of both the Campuses and other activities of the University.

In the course of the discussion, Sh. Ravinder Kumar, Dy. Secretary (Finance) suggested that after approval of Board of Management, the intimation regarding creation of above said posts as well as the posts already created in the 78th meeting of Board of Management may also be sent to the Govt. of NCT of Delhi.
