The National Handicapped Finance and Development Corporation (NHFDC) under the aegis of Department of Disability Affairs, Ministry of Social Justice & Empowerment, Government of India is an apex institution for promoting self-employment ventures for the Persons with Disabilities (PwDs). It channelizes finances through the State Channelising Agencies (SCAs) nominated by the respective State/UT Government(s). (Delhi SC/ST/OBC/Minorities and Handicapped Finance and Development Corporation is the SCA of NHFDC in Delhi. The detailed information is available on their website <a href="https://www.nhfdc.nic.in">www.nhfdc.nic.in</a>.)

Besides financial assistance for self employment, NHFDC also provides following financial assistance to the students with Disabilities:

1. Scholarship to Students with Disabilities: NHFDC is administering two (02) scholarships schemes i.e. <u>Trust Fund and National Fund</u> entrusted by Ministry of Social Justice & Empowerment, Government of India for Students with Disabilities. A total of 1500 scholarships are available to students with disabilities.

These two Scholarship schemes for students with disabilities are available for pursuing professional /technical education. Here, reimbursement of total course fee, hostel fee, books expenses, out of pocket allowances and expenses on aids and appliances (wherever applicable) are considered.

- <u>Under Trust Fund Scholarship</u>: 1000 scholarships @ Rs. 50,000/per year on an average are available for PwDs and
- <u>Under National Fund Scholarship</u>: 500 scholarships @ Rs. 12,000/- per year on an average are available.

2. **Education Loan:** Financial assistance in the form of loan is provided to students with disabilities at lowest interest rate for pursuing higher education in India or abroad where admission has been secured. The interest rate is only 4% for male students and 3.5 % for female students. A loan of upto Rs 10 lakhs is available for studies in India and upto Rs 20 Lakhs for studies abroad.

Any students may apply online on NHFDC website (www.nhfdc.nic.in)

Application in the prescribed format is to be submitted to the State Channelising Agency for sanction of loan as per the lending policy of NHFDC. A copy of the scheme is enclosed.
